BACKGROUND: Community Improvement Designation funds will be allocated to the following organizations:

1. **Smiles for Seniors Foundation- \$1,000** to support their efforts of providing emergency assistance for food, housing and utility payments as well as home and auto repair, and help pay for life saving prescriptions, and medical equipment for senior citizens in the 1st District.
2. **Assistance League of Temecula Valley - \$2,500** funding will be used to support the Operation School Bell program, which provides new, school appropriate clothing & shoes for students K-12 attending school districts within the First District.
3. **Hospice of the Valleys - \$2,000** funds will be used to offset the cost of hospice support for underinsured and uninsured patients of the 1st District. Specifically the funds will be used to help cover the costs of unreimbursed supplies and equipment, community education and bereavement costs not otherwise covered by insurance.
4. **Riverside University Health System Foundation - \$2,500** funding will be used to assist Riverside University Health System - Medical Center with specialized medical equipment.
