- 1. Temecula United Methodist Church MONKS \$3,500.00 the funding will be allocated towards the Birdies for Bread fundraiser, which benefits the St. Vincent de Paul Food Pantry in Temecula .
- 2. Foundation on Aging \$1,000.00 the funding will support the Senior Holiday Gift Card Event, which distributes Stater Bros. gift cards worth \$20 to seniors for holiday meals.
