

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Big Brothers Big Sisters of the Inland Empire - \$2,500 the funding will be used for community based mentoring programs.
2. Temecula Sunrise Rotary Foundation - \$1,500 the funding will be utilized for the annual Community Holiday Dinner in Temecula.
3. California Inland Empire - Boy Scouts of America - \$2,500 the funds will support camperships for children who reside in the Third District of Riverside County.
4. Voices for Children - \$5,000 the funding will support Riverside County Court Appointed Special Advocate (CASA) Program.
5. Habitat for Humanity Hemet / San Jacinto Inc. - \$2,500 the funding will be utilized for 16th Annual Diamond Valley Lake Marathon. This is a major fundraiser to assist families obtain homeownership in the Hemet / San Jacinto Valley.
6. Calicinto Ranch - \$5,000 the funding will provide camperships for at risk children of prisoners from the 3rd District of Riverside. These children attend camp and are mentored throughout the year.
