#### **BACKGROUND:**

# **Summary**

On February 10, 2015, Item 9-1, the Board of Supervisors approved a reduction to the project budget for a new amount of \$32,695,960 and approved the construction agreement with Pinner in the amount of \$22,913,600. A notice to proceed was issued and construction started on March 6, 2015. During construction, the project encountered some unforeseen conditions which caused additional design and engineering services as well as encountered construction delays resulting in the need to extend services provided by Kitchell and DLR. Kitchell's Amendment No. 2 in the amount not to exceed \$240,537 will cover the additional construction management hours during the extended construction period for a revised agreement value of \$1,253,452. DLR's Amendment No. 3 in the amount not to exceed \$170,381 will cover the additional design and engineering as well as construction administrative services for a revised agreement value of \$2,587,924. Both of the revised agreement values for Kitchell and DLR are within the previously approved project budget, therefore an adjustment to the budget is not required at this time.

During construction, a total of 16 additive and deductive change orders were issued for a total amount of \$1,529,338 (6.67%) increasing the overall construction contract to \$24,442,938. Pinner has completed the work with the exception of a few outstanding items on the punch list

which they will continue working to complete. The project has been inspected and found to comply with the contract requirements. This Board action will release \$612,024 now, which is half of the withheld retention, to Pinner and the remaining undisputed retention funds of \$612,024 for a total amount not to exceed \$1,224,048 after the Notice of Completion has been filed and the 35 day lien period has expired.

# **Impact on Residents and Businesses**

Construction of the new Alan M. Crogan Youth Treatment and Education Center will benefit the community by providing enhanced public safety and furthering the treatment and education of the youth in the juvenile justice system to reduce recidivism.

# Additional Fiscal Information

On September 13, 2016, there was an adjustment to the line items within the approved project budget. With this Board action, there is no increase to the project budget, however a further adjustment to the line items has been established and is as follows:



The County of Riverside and Kitchell CEM of Ontario, CA hereby agree to amend that certain agreement for construction management services associated with the Alan M. Crogan (formerly Van Horn) Youth Treatment and Education Center (FM08260000146) approved on July 1, 2014, Agenda Item 3-13, and first amendment approved on September 13, 2016, Agenda Item 3-22 as follows:

- Article 5 CONSTRUCTION MANAGER'S COMPENSATION subsection 5.1.2.3 shall be modified as follows:
  - (1) Construction Management Staffing: Not to Exceed Fee: \$1,253,452
- Article 15 Exhibit F. MASTER PROJECT SCHEDULE shall be modified as follows:
  - 9. Construction Complete July 31, 2017
  - 10. Occupancy Complete August 29, 2017
- Article 15 Exhibit N. STAFFING PLAN shall be amended to include the modified hours in the attached STAFFING PLAN R3.7 for new total hours of 9,447 and a Not To Exceed amount of \$1,236,202 plus reimbursable expenses totaling \$17,250. The additional compensation for Amendment No. 2 is Two Hundred Forty Thousand, Five Hundred Thirty-Seven dollars (\$240,537) for a new not-to-exceed lump sum fee of One Million, Two Hundred Fifty-Three Thousand, Four Hundred Fifty-Two dollars (\$1,253,452).
- All other terms and conditions of the Agreement shall remain in full force and effect.

## Between

# THE COUNTY OF RIVERSIDE AND DLR GROUP WWCOT

The County of Riverside and DLR GROUP WWCOT of Riverside, CA hereby agree to amend that certain agreement for Architectural and Engineering services associated with the Alan M. Crogan (formerly Van Horn) Youth Treatment and Education Center (FM08260000146) approved on June 19, 2012, Agenda Item 3.16, first amendment approved on June 25, 2013, and second amendment on January 26, 2016 as follows:

- Section II. SCOPE OF WORK shall be modified in the first paragraph to read as follows: "Architect shall provide additional services as outlined and specified in **Exhibit A-3** consisting of two pages attached hereto and incorporated herein by this reference".
- Section III. ARCHITECT'S SERVICES shall be modified to read as follows: "The Architect shall render the following services and related services as stipulated in Exhibit "A," "A-1," "A-2," and "A-3".
- Section IV.A.1. Determination of Amount shall be modified in the first paragraph to read as follows:
  - "For the services hereinabove required the County shall pay to the Architect, in the manner hereinafter provided, which includes the additional scope of work enumerated in **Exhibit** "A-3", and shall be paid as provided in paragraph IV.C. Payment."
  - "The COUNTY shall pay the Architect services performed and expenses incurred in accordance with the terms of Exhibit A, Exhibit A-1, Exhibit A-2, and Exhibit A-3 consisting of one (1) page and incorporated herein. The total amount of the original agreement and Exhibit A was Two Million, One Hundred Eighteen Thousand, Nine Hundred Fifty Dollars \$2,118,950. The additional compensation for Amendment #1 and Exhibit A-1 was One Hundred Twenty Five Thousand Dollars \$125,000. The additional compensation for Amendment #2 and Exhibit A-2 was One Hundred Seventy Three Thousand, Five Hundred Ninety Three Dollars \$173,593. The additional compensation for Amendment #3 and Exhibit A-3 is One Hundred Seventy Thousand, Three Hundred Eighty One Dollars \$170,381 for a new not-to-exceed total of Two Million, Five Hundred Eighty-Seven Thousand, Nine Hundred Twenty Four Dollars \$2,587,924, unless a written amendment to this Agreement is executed by both parties prior to performance of additional services."
- Section IV.C.1.f Construction Administration, the amount shall be changed to \$788,954.
- Replace page 13 of 13, Exhibit "E" with the attached revised page 13 of 13 Exhibit "E."
- All other terms and conditions of the agreement shall remain in full force and effect.

The following outlines our extra service request for additional services beyond the terms of our current Agreement:

#### 1.0 Scope of Services

- 1.1 Changes to Casework, Rec Yard and Security Fences (Bulletin 6): The following changes were requested by Probation: Casework was both added and deleted; security fencing in rec yards was modified in height and razor wire was eliminated and replaced with anti-climb fencing. Basketball backstop was added to the Assessment Unit rec yard.
- 1.2 Add and/or relocate cameras (Bulletin 7): The following changes were requested by Probation: Three (3) cameras were added to the project and incorporated into the Riser Diagram (Cameras B35, B36 and B37). Cameras A15 and A16 were relocated. Parapet details were developed for support of Cameras A15 and A16.
- 1.3 <u>Equipment, millwork, landscape, and irrigation (Bulletin 8)</u>: Probation requested modifications and additions of millwork and the addition of an exam table and magnetometer. EDA requested landscape and irrigation changes to the construction drawings which resulted in revisions to calculations and irrigation schedule.
- 1.4 Modifications to the Smoke Control system (Bulletin 10): Subsequent to project approval (which included a complete smoke evacuation system) by the California State Fire Marshal (SFM), the SFM required the design and construction of a smoke control system to provide a fully tenable environment during a fire event.

This request required the following changes: Removal and replacement of the existing smoke evacuation fans, structural and architectural modifications at the fan locations. A make-up air system was also required for the enhanced exhaust air demand. The Architect and the Mechanical Engineer assisted the designer of the fluid dynamic model which was the core of the smoke control design. Numerous changes to plans, schedules and details of three disciplines (architectural, mechanical and electrical) were required. The work was assembled and submitted to the SFM for review and approval. The approved submittal was then disseminated and coordinated with the Contractor.

Additionally, there were a number of modifications of the approved details to address client concerns. The Architects assisted in the review of the Contractor's cost proposals.

- 1.5 <u>Monument Sign (Bulletin 12):</u> Prepared design and construction drawings of a cast-in-place concrete, illuminated monument sign.
- 1.6 <u>BSCC Modifications (Bulletin 13):</u> Following previous approvals, BSCC Area Representatives requested multiple changes to the construction design/details and utilities of the project. Modified specifications for utilities were required. Coordination with the Contractor is required.
- 1.7 <u>Hydronic Piping Relocation</u>: Due to the Contractor's claim that the subcontractors could not fit the hydronic piping in the ceiling space and the Contractor's refusal to provide the delegated design per the Contract Documents, DLR Group provided a design and calculations to relocate the hydronic piping to the roof.
- 1.8 Extension of Construction Administrative Services: Based on a 395-day duration for Construction Contract Administration on the project and a commencement date of April 4, 2015, as of May 31, 2017 (the Contractor's current date of substantial completion), DLR Group has extended its services 12.86 additional months. This extension has resulted in costs beyond the budgeted resources.

#### 2.0 Professional Fee

2.1 DLR Group and its consultants have provided the additional services described under Scope of Services for a fixed fee of One Hundred Seventy Thousand Three Hundred Eight One Dollars (\$170,381.00). The breakdown of this fee is as follows:
