#### **BACKGROUND:**

#### Summary

By Minute Order 3-14 of October 4, 2016, the Board of Supervisors entered into a contract with Calpromax Engineering, Inc. of Placentia, CA for the construction of Country Club Drive and Adams Street Traffic Signal and Lighting Project in the community of Bermuda Dunes. The originally authorized amount of the contract was \$314,891. The total amended contract is \$289,501 which is 8.1% less than the originally authorized amount. The decrease in the total contract price was the result of a reduction in various bid items of work required to complete the project per the approved plans.

The work was completed in conformance with the plans and specifications and the contractor was granted relief of maintenance on February 17, 2017. Work Order Number C5-0086.

County Counsel has approved the Notice of Completion as to legal form.

#### **Impact on Residents and Businesses**

The construction of this traffic signal has improved traffic safety by controlling traffic movements.

If the total pay quantity of any item of work required under the contract varies from the Engineer's Estimate by 25 percent or less, payment will be made for the quantity of work of said item performed at the contract unit price, unless eligible for adjustment pursuant to Section 4-1.03C, "Changes in Character of Work."

This project was funded with \$289,501 of Eastern County DIF Signal Mitigation fund.

# Contract History and Price Reasonableness

Six bids were received on July 13, 2016, ranging from \$314,891 to \$378,498. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by Calpromax Engineering, Inc. in the amount of \$314,891, which is \$28,141 (9.8%) higher than the Engineer's Estimate.


