BACKGROUND: Community Improvement Designation funds will be allocated to the following organization:

1. **California Riverside Ballet - \$1,500** funds will be used to assist with student tuition for The Academy Program, a dance training program for underserved youth, at the Ysmael Villegas and Arlanza Community Centers.
2. **Calicinto Ranch, Inc. - \$1,500** funds will be used for the Apple Seed Kids Program. Apple Seed Kids provides year-round programs and events for children whose parents are incarcerated. This funding will allow 10 of these children in the 1st District to attend a 3-5 day camp.
3. **Riverside County Foundation on Aging - \$2,820** funds will be used to assist the Foundation with their Holiday Gift Program. Through this Program, seniors are selected from each senior center in the 1st District to receive a Stater Bros. gift card to be used for the holidays.
4. **Inland Empire Buffalo Soldiers Heritage Association - \$500** funds will be used to assist the Association in providing a Thanksgiving Dinner for homeless, impoverished and needy veteran families this holiday season.
