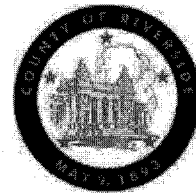





**BACKGROUND:**

**Summary**
