He is best known for his popular game show "Let's Make a Deal" which debuted in 1963 and ran until 1986 in multiple formats.

An instrumental force in the desert, Monty was active in charities throughout the Coachella Valley and will always be remembered as a man who liked making people happy through his charity work. He had a home in Cathedral City, where a street, Monty Hall Drive, is named in his honor. He was especially supportive in the local Variety Chapter – Children's Charity of the Desert, the Arthritis Foundation, and the Palm Springs International Film Festival. This year he worked on the annual Variety Care for Kids Radiothon.

Throughout his lifetime, Monty hosted "thousands" of charity events, including 65 telethons, and is credited with raising more than \$1 billion. He received over 500 awards, including the lifetime title of Variety International Chairman. In 2013, the Indian Wells Rotary Club honored him with an All-Star Tribute.

Monty's wife of nearly 70 years, Marilyn Hall, preceded him in death in June. He is survived by his daughters Joanna Gleason and Sharon Hall and his son Richard Hall.
