In 1950, Harry joined his father in the Coachella Valley where the family had been farming table grapes since the mid-1930's. In the table grape industry, he pioneered many growing and packing techniques that are still in use today. They include the brushing of certain varieties to reduce compactness; running sprinklers to create dormancy; the first forced air cooling system (1957) for grapes in the Coachella Valley; and the bagging of grapes in vexar meshed bags.

Active in the community, Harry served on the Coachella Valley Unified School District Board of Trustees in 1960's and was the first chairman of the Desert Grape Advisory Board in 1966. He, among other growers in California, was involved in the formation of the California Table Grape Commission in 1967.

Harry was preceded in death by his sister Dorothy Kandarian and daughter Elyse Carian. He is survived by his sister Lucille Huether, daughter Barri Carian, sons Robert and Blaine Carian, five grandchildren, and five great-grandchildren. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.

The Board of Supervisors commemorates his service to the County of Riverside.
