BACKGROUND:

Summary

The Transportation Improvement Program (TIP) provides for the resurfacing of various roads. The project propose to resurface the following roads:

Road	Chiriaco Road and between Chiriaco Road and Pinto Road	

Roadway resurfacing is needed due to deteriorated pavement conditions. These six roads have been combined to bid as one project to reduce overhead costs and receive more favorable unit costs associated with larger quantities of work.

On April 28, 2017, Senate Bill 1 (SB1) was passed to improve the state's aging transportation infrastructure, particularly the roads and bridges. Because of this, the County is now able to improve the condition of roads in need of resurfacing and reconstruction and has included them in the County TIP. Without SB1 these needed road repair projects would have been shelved until funding became available.

The proposed improvements on **Harrison Street** include overlaying the pavement with Asphalt Rubber Hot Mix, installation of detector loops, replacement of existing signs, application of striping, pavement markings, pavement markers, reflectors and construction of associated improvements.

The proposed improvements on **Robert Road** include overlaying the pavement with Hot Mixed Asphalt (HMA), installation of detector loops, replacement of existing signs, application of striping, pavement markings, pavement markers, reflectors and construction of associated improvements. Additionally, installation of curb ramps, replacement of a damaged sidewalk, construction of a

concrete spandrel and cross gutter and replacement of signs. Furthermore, a portion of the roadway will be reconstructed, and an area adjacent to this reconstructed area will be slurry sealed, near a fire station at the intersection of Robert Road and Ramon Road.

The proposed improvements on **Airport Boulevard** include overlaying the pavement with HMA, application of striping, pavement markings, pavement markers, reflectors, reconstruction of curb ramps and construction of associated improvements.

The proposed improvements on **Tyler Street** include overlaying the pavement with HMA, application of striping, pavement markings, pavement markers, reflectors and associated improvements. The easterly portion of Tyler Street from 54th Avenue to approximately 1300 feet southerly, is located within the jurisdiction of City of Coachella (City). The Transportation Department in coordination with the City has developed the scope of work to improve Tyler Street within the City limits along with the County's resurfacing project. A cooperative agreement to reimburse the County for the construction and inspection costs will be processed prior to or concurrent with award of the project construction contract.

The proposed improvements on **Chiriaco Road and Summit Road** include overlaying the pavement with HMA, application of striping, pavement markings, pavement markers, reflectors, replacement of signs and construction of associated improvements.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental Findings

Because the Harrison Street, Robert Road, Airport Boulevard, Tyler Street, Chiriaco Road and Summit Road resurfacing projects consists of maintenance and repair of an existing public facility, and there is no expansion of an existing roadway, this project qualifies for a Class 1 Categorical Exemption under Section 15301 (c) of the CEQA Guidelines. In accordance with Section 15301 (c), Class 1 projects consist of the operation, repair and maintenance of existing public facilities, such as highways, streets, sidewalks, gutters, bicycle and pedestrian trails and similar facilities. Furthermore, the Coachella Valley MSHCP states that necessary operation and maintenance activities conducted for safety purposes along existing roadways are considered covered activities. The County Transportation Department is requesting that the Board approve this environmental determination.

Impact on Residents and Businesses

The purpose of this project is to resurface these road segments to provide the public with a smooth paved roadway that will improve the safety and efficiency of the roadway.

The work is scheduled to begin in the Spring of 2018. The work will be phased to keep the road open during construction as much as possible and will take approximately three months to complete.

Additional Fiscal Information

The construction contract is estimated to cost approximately \$2,403,436. Construction is expected to begin and finish in FY 2017/2018 and will be funded with Gas Tax /SB1 and City of Coachella funds.





RESURFACING AIRPORT BLVD TO 54TH AVE IN THE COACHELLA VALLEY AREA











VICINITY MAP - TYLER

PROJECT DESCRIPTION: The Riverside County Transportation Department (RCTD) is proposing to rehabilitate Tyler Street, commencing from Airport Boulevard in the Thermal Community and terminating at 54th Avenue in the City of Coachella. Tyler Street varies in width from 26 feet to 49 feet. The proposed improvements include Cold-In-Place and overlaying the pavement with Hot Mixed Asphalt (HMA). The improvements also consist of re-striping the road, application of pavement markings and pavement markers, and installation of reflectors. Furthermore, improvements will consist of placing safety edges, shoulder backing, and replacement of signs. Tyler Street will not be widened. Note: If tree trimming and removal occurs during the migratory bird breeding season (February 1 through September I), a preconstruction nesting survey is required pursuant to the Migratory Bird Treaty Act (MBTA). No additional right-of-way will be required.

ENVIRONMENTAL ANALYSIS:

Because the Project consists of maintenance and repair of an existing public facility; and there is no expansion of an existing roadway, this Project qualifies for a Class 1 Categorical Exemption under Section 15301 (c) of the CEQA Guidelines. In addition, the Coachella Valley MSHCP states that necessary operation and maintenance activities conducted for safety purposes along existing roadways are considered Covered Activities. ¹

PROJECT SPONSOR: County of Riverside Transportation Department

PROJECT LOCATION: Thousand Palms Community, Unincorporated Riverside County

SUPERVISORIAL DISTRICT: 4th District

PROJECT DESCRIPTION: The County of Riverside Transportation Department proposes to collectively resurface approximately 1650 linear feet on Chiriaco Road (750 feet) and Summit Road (900 feet). The resurfacing will occur on Chiriaco Road will commence form Summit Road to 750 feet east of Summit Road. The resurfacing on Summit Road will commence from Chiriaco and terminate at Pinto Road, excluding the bridge deck. Note: Caltrans Permit will be needed for work being done adjacent to the bridge going over the I-10. Chiriaco Road and Summit Road are both two-lane facilities; and each has a roadway width of 32 feet.

The proposed project will include milling the existing Asphalt Concrete to a depth of 0.50 feet (0.75 feet at bridge termini) and paving the roadbed with 0.50 feet of Hot Mixed Asphalt (HMA) (.75 at bridge termini), Additional work will include installation of shoulder backing, reapplication of pavement markings, striping, installation of reflectors, removal of/ and replacement /salvaging of traffic signs. No additional right-of-way nor temporary construction easements will be required to implement the proposed improvements. All improvements are to be done in the same footprint of the existing roadway.

ENVIRONMENTAL ANALYSIS: Because the Project consists of rehabilitation and repair of an existing public facility; and there is no expansion of an existing roadway, this Project qualifies for a Class 1 Categorical Exemption under Section 15301 (c) of the CEQA Guidelines. In addition, the Coachella Valley MSHCP states that necessary operation and maintenance activities conducted for safety purposes along existing roadways are considered Covered Activities. ¹
