BACKGROUND:

Summary

On May 23, 2017, the Board awarded Road Builders, Inc. the contract for the Construction of the 2017 Site Improvements at the Anza, Beaumont, Double Butte, Edom Hill, Hemet, Homeland and Idyllwild Closed Landfills and the open Badlands Landfill. The total original contract amount was \$410,609.40; and the final contract amount was \$398,604.54.

This project included certain construction work at the Anza, Beaumont, Double Butte, Edom Hill, Hemet, Homeland, and Idyllwild Landfills. Planned construction work at the open Badlands Landfill was deleted, and construction work at the closed Mira Loma Landfill was added. This project has improved the longevity of hardscape drainage structure systems at five closed landfills; enhanced the integrity of the earthen cover systems at two closed landfills; increased the capacity of onsite surface drainage retention at one closed landfill; and provided onsite presence of large rock boulders for mitigating trespassing activities at one closed landfill that contains archaeological sites/cultural resources.

The construction of this project was completed within authorized budget, and within the allowed working days specified in the Contract. Upon approval of completion of the work by the Board, the retention fund balance is \$19,930.23. This Board action will allow for release of these retention funds to Road Builders, Inc.

Impact on Residents and Businesses

The enhancement and protection of the landfill cover and drainage systems at these eight closed sanitary landfills contribute to the health of the environment in which Riverside County residents live, work and play. Implementation and maintenance of physical barriers to mitigate trespassing help to discourage activities potentially detrimental to onsite County assets and cultural resources.

Additional Fiscal Information

This is an administrative action to file the Notice of Completion and no additional funds are being requested.

Contract History and Price Reasonableness

The final contract cost is less than the authorized budget for this project which was originally competitively awarded, with Road Builders, Inc. submitting the lowest bid out of three (3) bids received.


