An instrumental force in the community, Paula was an excellent public speaker with natural leadership ability. She was active in several organizations including the Corona Chamber of Commerce, the Soroptimist Club of Corona, and the Corona, Menifee/Sun City, and California Chapters of the Woman's Improvement Club. Paula and Harry enjoyed scuba diving, flying planes, attending countless community and political functions, and spending quality time with their family, dogs, and an aviary full of birds.



Born on February 25, 1926 in Elgin, Illinois, Richard proudly served our nation during World War II, enlisting in the United States Navy in 1943. He was initially a landing craft operator in the Pacific Islands and later volunteered as a Navy Frogman with the Underwater Demolition Teams (UDT), predecessors of the Navy SEALs.

After rigorous training, Richard became a member of UDT-16 where he was nicknamed "Red Dog." They were key in the Philippine Liberation campaign and Battle of Okinawa. He was honorably discharged in 1946. He also served in the Marine Corps Reserves following the war.

A successful painting contractor, Richard was known as "Rembrandt." He painted the homes of many desert community residents of the Coachella Valley and later became a furniture refinishing and repairman.

Active in the community, Richard was dedicated to serving others. He volunteered with the Disabled American Veterans, Veterans of Foreign Wars, UDT Seal Museum Association, Fraternal Order of UDT Seals, American Legion, Lions Club, children's reading programs, special education programs, and Angel View Crippled Children's Hospital.
