BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the November 7, 2017 Consolidated General Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On October 3, 2017, the Board of Supervisors approved the conduct of election services for the Consolidated General Election. This election includes certain local jurisdictions. The local jurisdictions will reimburse the Registrar of Voters for the full cost of conducting their elections. Election costs fully reimbursable from local jurisdictions are approximately \$315,000.

The election was held on November 7, 2017 with 24.63% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the Consolidated General Election.

Impact on Residents and Businesses

Registered voters who reside in the County of Riverside had the opportunity to elect candidates for local jurisdiction offices.

Additional Fiscal Information

As approved by the Board of Supervisors on October 3, 2017, local jurisdictions will reimburse the Registrar of Voters for the full cost of conducting their election.

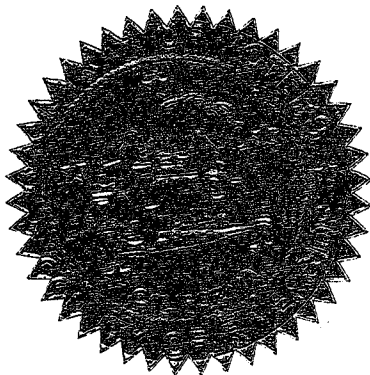
