

BACKGROUND: Community Improvement Designation funds will be allocated to the following organizations:

1. **Riverside Dickens Festival - \$1,000** - funds will be used to support one of the signature events in Riverside-- the annual cultural festival celebrating the life and works of Charles Dickens and the Victorian Era. This event is free and open to the public.
2. **Martin Luther King High School, "King High Remembers" - \$1,500** funding will be used to provide assistance with costs of the King High Remembers program, a Veterans Oral History Project.
3. **Riverside County Works - \$1,000** funds will be allocated to support Riverside County Workforce Investment Board's Scholarship Program at the Annual Character Counts Youth Awards Ceremony.
