BACKGROUND:

Summary

On April 12, 2016, Item 3-13, the Board of Supervisors (Board) approved the RUHS Generator Fuel Line Replacement project and plans and specifications for bidding and construction. Upon completion of the bid process, the scope of work was re-evaluated and it was determined that a change to the installation and programming process would deliver the project in a more timely manner, alleviated the need for any changes to the switchgear, alleviated the need for electrical power interruption to the hospital in a total reduced cost of over \$200,000.

On March 1, 2016, Item 3-12, the Board approved the construction contract for Job Order Contract No. 007 between the County of Riverside (County) and Angeles. Pursuant to the contract, a job order was issued for the RUHS Generator Fuel Line Replacement project in the amount of \$162,724, to replace the generator fuel lines which had reached their end of life cycle and upgrade the day tank fuel system located in the lower level of Building F, within the generator room of the hospital.

Angeles has completed the work to the project, and has been inspected and found to comply with the contract requirements. This Board action will release the undisputed contract retention funds in the amount of \$8,136 to Angeles after the Notice of Completion has been recorded and the 35 day lien period has expired per contract terms.

Impact on Residents and Businesses

The RUHS Generator Fuel Line Replacement project has enhanced the daily operations of the generator room to ensure that RUHS is in compliance with OSHPD.


