BACKGROUND

Change of Zone No. 7929 changes the zoning on 156 parcels totaling approximately 2,104 acres from various zones to either the Wine Country – Winery Zone or the Wine Country – Winery Existing Zone. The public hearing for Change of Zone No. 7929 was held on October 31, 2017, as Agenda Item No. 18.2. At the conclusion of the public testimony, the Board of Supervisors closed the public hearing, found no new environmental documentation is required, and tentatively approved Change of Zone No. 7929 with the addition of five parcels to the zone change.

In accordance with Section 20.3a.e. of Ordinance No. 348 and Government Code Section 65857, on November 15, 2017, the Board of Supervisors modification to the Planning Commission's recommendation was referred back to the Planning Commission for a report and recommendation. The Planning Commission approved the report and modification by the Board of Supervisors.

Pursuant to Section 4.1 of Ordinance No. 348, the County's unincorporated area is placed in mapped zoning districts. Adoption of Ordinance No. 348.4870 will finalize the Board's tentative action on Change of Zone No. 7929, formally change the properties' zoning classification and amend the County's zoning map to reflect the new zoning classifications.

IMPACT ON RESIDENTS AND BUSINESSES

The impacts of processing Change of Zone No. 7929 and adoption of this ordinance have been evaluated through the environmental review and hearing processes by Planning staff, the Planning Commission, and the Board of Supervisors. The opportunity for public review and comment was provided during the public hearings scheduled for this change of zone and any verbal or written testimony provided by the public was considered by the hearing body at that time. Today's action will finalize the Board's tentative action that was taken on October 31, 2017, and formally change the zoning classification on the subject parcels.

SUPPLEMENTAL: ADDITIONAL FISCAL INFORMATION

The total cost to complete Change of Zone No. 7929 is approximately \$133,472. The Planning process for this project started in December 2016. The cost includes funds spent on community outreach, environmental reviews, preparation for hearings, and public hearings.







OVERALL BOUNDARIES AND INDEX SHEET 1 OF 78




