#### **BACKGROUND:**

#### Summary

Slurry seal treatment is provided as preventative maintenance to extend the life of the pavement and postpone more costly pavement rehabilitation. The slurry seal treatment seals small cracks, restores lost flexibility to the pavement surface and help preserve underlying pavement structure. This project includes various roads located within the 4<sup>th</sup> and 5<sup>th</sup> Supervisorial Districts. The specific roads are listed in "Attachment 1".

This project proposes Slurry Seal, Cape Seal or Microsurfacing surface treatments based on the existing pavement conditions.

The Slurry Seal treatment consists of an application of a mixture of asphalt emulsion, aggregates, water and other additives over the existing asphalt pavement surface. This work includes road cleaning, crack repairs, application of slurry seal treatment, new pavement markings and raised pavement markers. All roads will be swept several times, at specified intervals, after the slurry has been applied.

The Cape Seal treatment adds a layer of "chips" or small crushed rock (screenings), and the slurry seal is placed over the chips and acts as a "wearing course" in areas of higher vehicle traffic.

The Microsurfacing treatment uses a Microsurfacing Emulsion that is suitable for pavement needing a higher level of treatment then slurry or chip. The emulsion is "scrubbed" into the pavement with brushes; however, "chips" and slurry seal are not placed over this treatment.

The work included in this project includes the reconstruction of one-hundred two (102) existing curb ramps to bring them up to current standards. The specific ramps locations are listed in "Attachment 2"

The bid documents include the following bid schedules of work:

Base Bid:

Slurry Seal and associated work on selected County maintained roads.

Alternate Bid Schedule 1: Concrete curb ramps and associated work.

Alternate Bid Schedule 2: Slurry Seal and associated work on selected City of Beaumont

maintained roads.

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid of the sum of all bid schedules.

The City of Beaumont (City) has been invited to participate in the project, and the slurry seal work within the City is included on bid proposal as Alternate Bid Schedule 2. If the low bid is approved and concurred to by the City, a Reimbursement Agreement between the City and County of Riverside will be submitted to the Board of Supervisors for approval prior to or concurrent with the award of the construction contract.

The submitted plans and specifications have been approved as to form by County Counsel.

Project Nos.: C8-0009 and C8-0010

#### **Environmental Findings**

CEQA Guidelines Section 15301(c) describes the maintenance, repair and minor alteration of existing public facilities, with negligible or no expansion of an existing facility, to be considered as a categorical exemption under CEQA. This project qualifies under this exemption since it is a repair and maintenance activity taking place on existing County roads.

In addition, the project is covered by the general rule of the CEQA Guidelines Section 15061(b)(3). The slurry seal treatments involve maintenance and repair to existing paved roads within existing right of way. As a result, there is no possibility that the project will have a significant effect on the environment. Therefore, the project is exempt from CEQA.

#### Impact on Residents and Businesses

The slurry seal treatment extend the life of the pavement thereby reducing the need for more expensive types of resurfacing that can be up to ten times more costly.

The reconstruction of curb ramps will improve the access and safety of disabled persons using the pedestrian facilities along the roadways. In addition, bringing the curb ramps up to current accessibility standards contributes toward fulfilling the County Transportation Department's goals as stated in its ADA Self-Evaluation and Transition Plan as required by Title II of the Americans with Disabilities Act (ADA).

#### **Additional Fiscal Information**

The construction contract is estimated to cost approximately \$3,063,676 and construction is anticipated to be completed in FY 2017/2018. The slurry seal contract will be funded with Gas Tax/HUTA.





**PROJECT DESCRIPTION:** The Riverside County Transportation Department (County) proposes to provide slurry seal treatment (which may include a chip seal, microsurface, scrub or slurry seal) to existing pavement surfaces on various roads located in unincorporated areas of Supervisorial Districts 4 & 5 in Western and Eastern Riverside County. The attached exhibit and list identifies the roads for the slurry seal improvements.

Slurry seal treatments consist of an application of asphaltic emulsion covered by a sand/emulsion mixture. The purpose of the treatment is to extend the life of the pavement or to postpone the need for more costly pavement rehabilitation. The work involves cleaning and sealing cracks, then applying the slurry seal over the existing asphalt concrete surfaces. The specific type of seal treatment will vary based on the existing pavement conditions. The work also involves removing and replacing thermoplastic crosswalk and pavement markings; painting traffic stripes and other associated work as may be required. The work is limited to the existing pavement which is within the road right of way.

ENVIRONMENTAL ANALYSIS: The proposed project will extend the life of the pavement of the treated roads, which is a benefit to the traveling public. The project consists of maintenance and repair of an existing public road. There is no expansion of use of the road as a result of the project.

The Western Riverside County Multiple Species Habitat Conservation Plan (MSHCP) and the Coachella Valley MSHCP states that necessary operation and maintenance activities conducted for safety purposes along existing roadways are considered Covered Activities.

The Riverside County Transportation Department Staff conducted a review of the above referenced project and has determined that the proposal qualifies for a Categorical Exemption per the California Environmental Quality Act (CEQA) Guidelines.

The Riverside County Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA) Guidelines, based on the following:

Section 15301 (c) – Existing Facilities: The project proposes to treat paved roadway surfaces with slurry seal treatments on various roads in Western and Eastern Riverside County unincorporated areas. The project consists of maintenance and repair of an existing public structure involving no expansion of use and is exempt from CEQA under Section 15301 (c).

Section 15061 (b) (3) - General Rule Exemption: The project is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The project involves maintenance of an existing street, and therefore it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
