BACKGROUND/APPOINTEE INFORMATION: The Honorable Supervisor John F. Tavaglione is a fourth-generation Riverside resident, and currently serves as Chairman of the Riverside County Board of Supervisors, a distinction that he has held five times during his tenure as Supervisor. Now in his 23rd year as a County Supervisor, Supervisor Tavaglione continues to exemplify what it means to serve his country, his community, and his fellow man.

Supervisor Tavaglione's legacy of accomplishments spans decades of public service. A proud veteran who served in the U.S. Army from 1968 through 1970, he was elected to the Second Supervisorial District on November 7, 1994, and soon after was sworn into office on January 3, 1995. Immediately prior to his election to the Board of Supervisors, Tavaglione was a member of the Riverside City council. Tavaglione also served the public as a Riverside City Planning Commissioner and member of the Riverside Public Utilities Board. He was also a Level 1 Reserve Police Officer at the Riverside Police department for 10 years. His district currently includes the unincorporated communities of Coronita, El Cerrito, Home Gardens, Highgrove and the cities of Corona, Norco, Eastvale, Jurupa Valley and western portions of the City of Riverside.

As a member of the Board of Supervisors, Supervisor Tavaglione has tirelessly devoted much of his life to improving the economic and social future of residents of Riverside County and the Inland Empire Region. He has held leadership roles on boards and commissions for regional transportation issues, healthcare, community and economic development, and parks and open space preservation because of his strong fiscal and organizational management. Along with his depth of knowledge of the inner workings of the County and its departments, he continues to be an effective advocate through his memberships and affiliations:

For the past twenty one years, Supervisor Tavaglione has been a member of the Board of Directors and Executive Committee of the California State Association of Counties (CSAC) representing Riverside County, and was elected by California's 58 counties in 2010-2011 to serve as CSAC President, where he worked closely with Governor Jerry Brown and his administration in negotiating Public Safety and Health/Human Services Realignment. Supervisor Tavaglione is currently serving as Chairman for the Executive Committee for the Riverside County Transportation Commission (RCTC), of which he has been a member for the past 15 years, and he is an Executive Committee Member of the Western Riverside County Conservation Authority (RCA). He also served 16 years as a member of Riverside County's Local Agency Formation Commission (LAFCO).

For his efforts and leadership in navigating the County through the tough fiscal climate of the last recession, Supervisor Tavaglione was recognized as Elected Official of the Year by PublicCEO, a local government news aggregate website dedicated to providing a statewide perspective on California's cities, counties, and special districts. His accomplishments include his appointment by State Supreme Court Chief Justice Ronald George to the 19 member State of California Probation Services Task Force; and appointment to the Board of Inland Empire Health Plan (IEHP), the State of California's second largest public health plan serving Medi-Cal, Healthy Kids, and the Medicare Advantage Special Needs populations in the Riverside/San Bernardino County Region.

Supervisor Tavaglione has had a lasting impact not only on countywide regional issues, but to his fellow citizens. He was an advocate and guiding force in the incorporation of the County's two newest cities, Eastvale and Jurupa Valley, which incorporated in 2010 and 2011 respectively. He has been a strong supporter of programs for collaborative youth programs that provide educational and growth opportunities for the County's youth population. Supervisor Tavaglione strongly supports the Greater Riverside Dollars for Scholars and was President of the Southern California Dollars for Scholars Governing Board. John and his wife Jan have helped to send hundreds of students to college by hosting an annual fundraiser where all proceeds go towards scholarships for graduating high school seniors in his district.

Had it not been for his drive, determination, and vision as a member of the Board of Supervisors, the County of Riverside would not enjoy the opportunity and prosperity it has today. Therefore, it is only fitting and proper that the CAC Annex be renamed in his honor, as the "John F. Tavaglione County Administrative Center Annex."

Individual Speaker Limits:

Individual speakers are limited to a maximum of three (3) minutes. Please step up to the podium when the Chairman calls your name and begin speaking immediately. The Chairman adheres to a strict three (3) minutes per speaker. Note: If you intend to give your time to a "Group/Organized Presentation", please state so clearly at the very bottom of the reverse side of this form.

Group/Organized Presentations:

Group/organized presentations with more than one (1) speaker will be limited to nine (9) minutes at the Chairman's discretion. The organizer of the presentation will automatically receive the first three (3) minutes, with the remaining six (6) minutes relinquished by other speakers, as requested by them on a completed "Request to Speak" form, and clearly indicated at the front bottom of the form.

Addressing the Board & Acknowledgement by Chairman:

The Chairman will determine what order the speakers will address the Board, and will call on all speakers in pairs. The first speaker should immediately step to the podium and begin addressing the Board. The second speaker should take up a position in the front row to quickly step up to the podium after the preceding speaker. This is to afford an efficient and timely Board meeting, giving all attendees the opportunity to make their case. Speakers are prohibited from making personal attacks, and/or using coarse, crude, profane or vulgar language while speaking to the Board members, staff, the general public and/or meeting participants. Such behavior, at the discretion of the Board Chairman may result in removal from the Board Chambers by Sheriff Deputies.
