BACKGROUND:

Summary

Ordinance 671 requires fully burdened rates charged to the public and District Divisions be approved and adopted by the Board of Supervisors.

The District re-evaluated the Board-approved rates while considering the effects of a stabilizing economy on the revenue and expense streams of the various funds, and factoring the trends of cost recovery and the need to be business friendly into the evaluation of the proposed rates presented as an attachment to this Form 11.

Rate reductions are proposed for Funds 15000 (Special Accounting) and 40670 (Encroachment Permits). An average rate increase of 6.92% is proposed for Fund 40660 (Subdivision Operations). The rates for Fund (40660) were last changed in FY2013-14 when they were reduced by an average of 14.2%. The ten year weight adjusted increase for Fund 40660 is 1.4%. These changes are commensurate to and in line with the recent rate adjustments made by Transportation and Planning on March 7, 2017 (Item 3.32).

The calculated rates for these listed funds were developed in conformance with standard cost accounting guidelines and are intended to fully recover the cost of services and the administration of these funds. The District will continue to annually evaluate and monitor the balance between unrestricted net assets and unrestricted cash while making provisions for contingency or economic uncertainty reserves in each fund.

Impact on Residents and Businesses

The District is proposing rate changes for the following funds:

A reduction to the administrative overhead rate is proposed for Fund 15000, Special Accounting. The proposed 6.36% rate reduction will bring the revenue in line with the operating expenses. The rate reduction will reduce the revenue by approximately \$44,000 annually.
