#### **BACKGROUND:**

#### **Summary**

On July 13, 2016, the Board awarded Wood Bros., Inc. the contract for the Excavation, Hauling, and Stockpiling Daily Cover Material at the Badlands and Lamb Canyon Sanitary Landfills. The total original contract amount was \$1,134,000.00. Two Change Orders to the contract were executed. After several heavy rainstorms at the Lamb Canyon Landfill, a localized landslide occurred within a native cut slope area. Change Order #1 reassigned a portion of Bid Item #4 to the repair of the landslide area. Change Order #2 reassigned the remaining portions of bid Item #4 to Bid Item #3 for the Excavation, Hauling, and Stockpiling Daily Cover at Badlands Landfill. No additional costs occurred as a result of the change orders.

The construction of this project was satisfactorily completed on time and within budget. The Department has accepted the work; therefore the Department recommends filing a Notice of Completion. The final cost for the project is \$1,066,074.13, which is less than the authorized budget.

This Board action will allow for release of retention funds in the amount of \$53,303.71 to Wood Bros., Inc., after the lien period has expired.

#### Additional Fiscal Information

This is an administrative action to file the Notice of Completion and no additional funds are being requested.

#### **Contract History and Price Reasonableness**

The final contract cost is less than the authorized budget for this project which was originally competitively awarded, with Wood Bros., Inc. submitting the lowest bid out of five (6) bids received.
