



**BACKGROUND:** The non-profit group, Forest Folk Inc., provides shuttle services to underserved senior, disabled, and low-income populations, as well as residents and visitors. They are in need of a van-type vehicle to provide shuttle transportation on a scheduled route through Idyllwild and Pine Cove that will transport residents and visitors around the Idyllwild area and to large, local urban areas, including Hemet and the Coachella Valley Area. Medical and dental services, shopping, errands, and other appointments for services not available in Idyllwild communities will all require some type of transportation. For those in the community without the means to access transportation, public transportation becomes a necessity. The donation of a van to Forest Folk Inc. will help to address this public need.
