
1. Accept Columbia Street Resurfacing Project between Florida Avenue and Stetson Avenue in the East Hemet area as completed; and

BACKGROUND:

Summary

By Minute Order 3-44 of December 13, 2016, the Board of Supervisors entered into a contract with All American Asphalt of Corona, CA for the resurfacing of Columbia Street in the East Hemet area. The originally authorized amount of the contract was \$1,116,441. The total amended contract is \$1,017,300 which is 8.9% less than the originally authorized amount. The reduction in the total contract price was primarily the result of the elimination of various concrete items of work by the City of Hemet.

The work was completed in conformance with the plans and specifications and the contractor was granted relief of maintenance on June 30, 2017. Work Order Number C1-0557.

Impact on Residents and Businesses

The improvements have improved the service life of the existing infrastructure.

If the total pay quantity of any item of work required under the contract varies from the Engineer's Estimate by 25 percent or less, payment will be made for the quantity of work of said item performed at the contract unit price, unless eligible for adjustment pursuant to Section 4-1.03C, "Changes in Character of Work."


This project was funded with \$933,881 of Gas Tax funds and \$83,419 of City of Hemet funds.

Contract History and Price Reasonableness

Five bids were received on October 12, 2016, ranging from \$1,116,441 to \$1,419,000. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by All American Asphalt in the amount of \$1,116,441, which is \$3,558 (0.4%) lower than the Engineer's Estimate.

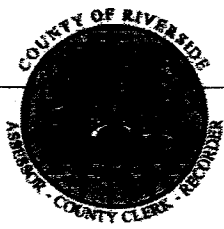

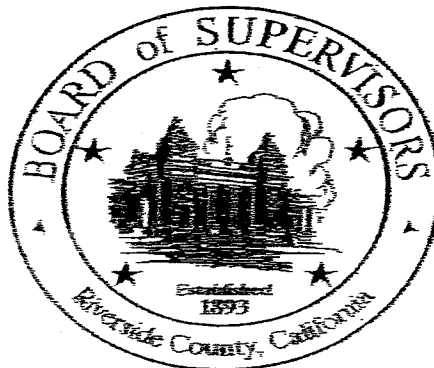
