BACKGROUND: Summary

The Transportation Improvement Program (TIP) provides for the construction of the Alessandro Boulevard Bike Lane Project located west of Meridian Parkway and south of the City of Riverside; and the Cajalco Road Resurfacing Project from Harley John Road to Kirkpatrick Road in the community of Lake Mathews.

Two projects are being combined to bid as one project in order to accelerate construction of the needed work. Additionally, efficiencies are gained by eliminating multiple bidding and administrative procedures, and by receipt of more favorable bids associated with larger bid quantities.

The County proposes to rehabilitate 2.3 miles of pavement along Cajalco Road from Harley John Road to approximately 650 feet east of Kirkpatrick Road. The existing pavement will be removed by cold planning and repaved with Hot mix asphalt, other work includes construction of asphalt concrete dike, shoulder backing, replacement of roadside signs, reconstruction of overside drains, repair of existing guardrails, replacement of detector loops, placement of pavement markings, and any other work as may be required.

The proposed improvements on Alessandro Boulevard include widening the roadway, constructing a retaining wall, and installing 465' of striped bike lane to provide a continuous bike path for bicyclist traveling eastbound on Alessandro Boulevard from the City of Riverside to the City of Moreno Valley.

The Questar Southern Trails Pipeline Company (Questar) owns and operates a 16-inch diameter high pressure gas pipeline within the County of Riverside (County) right-of-way, which is in conflict with the County's bike lane project. The County and Questar have executed a letter agreement which provides for the County to construct a retaining wall to protect the pipeline. The letter agreement was executed April 20, 2016.

SUBMITTAL TO THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE, STATE OF CALIFORNIA

By Minute Order dated April 18, 2017 (Agenda Item 3.22), the Board of Supervisors approved the Amendment No. 1 to the above referenced letter agreement, which was needed to allow for an increased retaining wall cost estimate. All costs associated with the design and construction of the retaining wall will be borne by Questar.

Cajalco Road between Harley John Road and Kirkpatrick Road was originally identified to be in need of resurfacing in 2012. On April 28, 2017, Senate Bill 1 (SB1) was passed to improve the state's aging transportation infrastructure, particularly roads and bridges. Because of this, the County is now able to improve the condition of roads in need of resurfacing or reconstruction and has included them in the County Transportation Improvement Program (TIP). Without SB1 these needed road repair projects would have been shelved until funding became available.

The Cajalco Road rehabilitation project is one of Riverside County's priority projects approved for use of the new Gas Tax/SB-1 funds.

The bid documents include the following bid schedules of work:

Base Bid Sch A:

Cajalco road Resurfacing and associated improvements

Base Bid Sch B:

Alessandro Blvd Bike Lane and associated Improvements.

Alternate Bid Sch. 1:

Construction of retaining wall for Questar.

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid of the sum of all bid schedules. Questar will reimburse the County for the construction cost for alternate bid schedule 1 if selected for award.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental Findings

Cajalco Road resurfacing is a minor alteration of an existing facility within the County right-of-way. No additional right-of-way will be required as part of the project. The project is exempt from CEQA pursuant to Section 15301(c), which describes the minor alteration of existing public facilities with negligible or no expansion of an esisting use. The proposed project improvements will occur on an existing roadway and will not expand the use beyond its existing use; consequently, the project qualifies as an exemption under Section 15301(c) of CEQA.

By Minute Order dated April 18, 2017 (Agenda Item 3.22), the Board of Supervisors approved the California Environmental Quality Act (CEQA) Notice of Exemption (NOE) for the Alessandro Boulevard Bike Lane project. Therefore, CEQA compliance has been completed for the Alessandro Boulevard Bike Lane project and no further action is required.

SUBMITTAL TO THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE, STATE OF CALIFORNIA

Impact on Citizens and Businesses

The purpose of the resurfacing project is to provide the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic. The bike lane project is intended to improve the safety and convenience for bicycle riders traveling eastbound from City of Riverside toward City of Moreno Valley.

The work is scheduled to begin in the spring of 2018. The work will be phased to keep the road open during construction and will take approximately one month to complete.

SUPPLEMENTAL:

Additional Fiscal Information

The construction contract is estimated to cost approximately \$1,203,765. Construction is anticipated to begin in the spring of 2018. The project will be funded with Gas Tax /SB1, Gas Tax / HUTA, SB 821 funds for which the Transportation Department successfully completed, and Questar.

There are no General Funds used in this project.

PROJECT DESCRIPTION: The Riverside County Transportation Department (RCTD) proposes to rehabilitate 2.3 miles of Cajalco Road by Cold Planing (CP)¹ the existing pavement 0.2' and overlaying with 0.3' of Hot Mix Asphalt. Cajalco Road is classified as an Expressway on the County of Riverside General Plan. Cajalco Road travels in an east-west direction between the project boundaries, which are approximately 650 feet east of Kirkpatrick Road to Harley John Road. Cajalco Road is currently a two lane facility with a roadway width that varies from 32 to 55 feet wide. The improvements will also include:

- Crack seal any cracks wider than ½"
- Remove and Replace AC dike
- Place Shoulder Backing
- Re-apply striping, pavement markers
- Remove / Salvage and replace signs
- Replace detector loops
- Reconstruct over side drains
- Repair guardrails
- Removal and Replacement of Damaged Metal Beam Guard Rail in kind

No additional Right-of-Way nor Temporary Construction Easements (TCE) will be required to construct the proposed improvement. All improvements will occur within the footprint of the existing road. The road profile will be raised by approximately 0.1 feet throughout the project limits.

¹ Cold Planing (CP) is the controlled milling of a pavement to restore it. This milled surface provides an excellent base for a smooth-riding asphalt overlay

ENVIRONMENTAL ANALYSIS:

Because the Project consists of operation, maintenance and repair via coldplaning and overlaying of an existing public facility; and there is no expansion of an existing roadway, this Project thus qualifies for a Class 1 Categorical Exemption under Section 15301 (c) of the CEQA Guidelines.

CEQA Finding:

The Transportation Department staff conducted a review of the project and determined that the project qualifies for a Class 1 Categorical Exemption under Section 15301 (c) of the CEQA Guidelines, Article 19 commencing with Section 15300. In accordance with Section 15301 (c), Class 1 projects consist of the operation, repair and maintenance of existing public facilities, such as highways, streets, sidewalks, gutters, bicycle and pedestrian trails and similar facilities.

The Riverside County Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:
