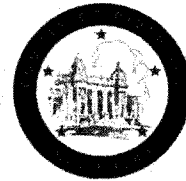

**Summary**

On September 20, 2016 (M.O. 3-11) the Board of Supervisors approved the Agreement with Best Best & Krieger, LLP for Professional Services for \$250,000 for activities related to Riverside County Broadband Master Plan in securing broadband networks throughout the county. The requested extension through June 30, 2018 will allow for Best Best & Krieger's assistance in the review of additional information provided by vendors responding to the RIVCOconnect Request for Participants (RFP) and for contract negotiations. The contract amount of \$250,000 remains the same through the term of the extension; no contract amount increase is requested.

There is no impact to the residents of Riverside County.


**Additional Fiscal Information**

**Contract History and Price Reasonableness**




