



BACKGROUND:

Summary

The Transportation Improvement Program (TIP) provides for the construction of the Mecca Area Sidewalks Project, located in the Community of Mecca. The County proposes to construct sidewalks along the following roads.

1. 6th Street (Date Palm Street to Dale Kiler Road)
2. Brown Street (5th Street to 6th Street)
3. Dale Kiler Road (5th Street to 7th Street)

Additional work includes removal and replacement of existing curb, gutter, reconstruction of driveways, cross gutters, removal of trees, relocation of roadside signs, placement of painted traffic stripe and thermoplastic pavement marking, and any other work as may be required.

By Minute Order dated January 17, 2017 (Agenda Item 3.42), the Board of Supervisors approved the California Environmental Quality Act (CEQA) Notice of Exemption (NOE) for the project. Therefore, CEQA compliance has been completed and no further action is required.

The submitted plans and specifications have been approved as to form by County Counsel.

Impact on Citizens and Businesses

The sidewalk project is intended to enhance public health, increase mobility for non-motorized users, and increase public safety. The construction of sidewalks will improve the safety and convenience for pedestrians in the community of Mecca who walk to downtown services including the schools, churches, bus stops, market place, medical clinic, library, post office, sports complex, and Boys & Girls Club.

The work is scheduled to begin in spring of 2018 and will take approximately two months to complete.

The construction contract is estimated to cost approximately \$538,967. Construction is expected to begin and finish in FY 2017/2018 and will be funded with, Gas Tax / HUTA and Active Transportation Plan (ATP) funds for which the Transportation Department successfully competed.

There are no General Funds used in this project.


