### **BACKGROUND:**

The Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports economic expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the members must come from the business community. In addition, WDBs are required to have representation from local community colleges and other training providers, as well as economic development and workforce program leaders. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two year terms.

Lea Petersen, Southern California Gas Companies Public Affairs Manager for over 10 years currently serves as a private sector representative of the WDB and chairs the WDB's West Regional Committee. She is also involved with several organizations like

the Greater Riverside Chamber of Commerce, Moreno Valley Black Chamber of Commerce, Corona Chamber of Commerce and Congressman Calvert's Science Technology Education Partnership. She is highly engaged in the community has received recognition for her community leadership. She is connected to various industry sectors and she brings great insight of the current and future community and business workforce needs. This plays a key role in developing and implementing the WDBs' 4-year local plan as mandated by WIOA.

Lea Petersen has expressed an interest in continuing to serve on the WDB as private sector representative for the first district. If reappointed she will serve a two-year term ending **January 24, 2020**.
