**BACKGROUND:**

The Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports economic expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the members must come from the business community. In addition, WDBs are required to have representation from local community colleges and other training providers, as well as economic development and workforce program leaders. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two year terms.

Cherilyn Greenlee, Deputy Division Chief for the State of California's Employment Development Department (EDD), currently serves as a public sector representative for the Workforce Development Board. Ms. Greenlee has over 25 years of public

workforce experience and is a local leader on workforce issues. Under her leadership EDD staff proactively partner with County staff to provide services at the county's Workforce Development Centers also known as America's Job Centers of California (AJCC). Ms. Greenlee is an expert on integrated service delivery, local partnerships and the provision of Wagner-Peyser services which are specifically mandated under WIOA.

Cherilyn Greenlee has expressed an interest in continuing to serve on the WDB as a Public Sector Wagner-Peyser representative for All Districts. If reappointed she will serve a two-year term ending **December 13, 2019**.
