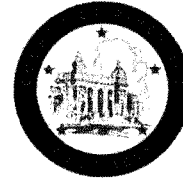

SUBJECT: TREASURER-TAX COLLECTOR: Timeshare Internet Tax Sale, TC-213, scheduled for May 17, 2018 through May 22, 2018, with Bid4Assets Inc., District 4. [\$55,624 Fund 11060 Tax Loss Reserve Fund]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve the intended timeshare internet tax sale, TC-213; (2) Approve and adopt the provision of the Revenue and Taxation Code Section 3698.5(a), 3698.5(c), 4703(a); (3) Adopt Resolution 2018-018 approving the sale of tax-defaulted property, prepared and approved by County Counsel, and (4) Instruct the Clerk of the Board to immediately forward a certified copy of the Board's Resolution to the Treasurer-Tax Collector following Board approval.

The above action will authorize the minimum bid on timeshare intervals to be offered for sale via the Internet with Bid4Assets, Inc.



BACKGROUND:

Summary

Properties for which taxes are not paid are sold to collect back taxes. After the property has been tax-defaulted for a period of five or more years from the original tax-default year, it becomes subject to the Treasurer-Tax Collector's "Notice of Power to Sell Tax Defaulted Property," which is then recorded.

If the property is not subsequently redeemed by the payment of all amounts due, it is offered for sale by the Treasurer-Tax Collector. This action will set in motion the Treasurer-Tax Collector's Timeshare Internet Tax Sale.

SUMMARY OF THE May 17, 2018 through May 22, 2018 Timeshare Internet Sale conducted via the Internet through Bid4Assets, Inc.

The Treasurer-Tax Collector proposes to offer a maximum of one hundred thirty-five (135) timeshare intervals of the Marriott and Shadow Ridge Timeshares located in Palm Desert, Westin Timeshares located in Rancho Mirage and PGA Timeshares located in La Quinta.

On May 17, 2018 at 8:00AM through May 18, 2018 at 9:00 AM

- a) One hundred thirty-five (135) timeshare intervals will be offered for a minimum bid of full redemption, plus the cost of sale per timeshare interval.

As indicated in Exhibit "A", the aggregate minimum bid for all parcels is \$504,866.00.

On May 18, 2018 at 9:00 AM through May 22, 2018, of the one hundred thirty-five (135) timeshare intervals that do not receive a bid between May 17, 2018 at 8:00 AM and May 18, 2018 at 9:00 AM, seventy (70) timeshare intervals will be reoffered at a reduced minimum bid of \$800.00, per timeshare interval, sixty-four (64) timeshare intervals will be reoffered at a reduced minimum bid of \$400.00, per timeshare interval and one (1) timeshare interval will be reoffered at the reduced minimum bid of taxes only plus cost of sale.

In general, the financial impact of tax sales can be summarized as follows:

- Sales at, or above, the amount of taxes owed have no direct negative impact on the County's budget.
- For this sale, if all parcels being reoffered for sale were to sell for only the reduced minimum bid, the maximum tax loss would be \$98,729.31. Taking into account the Teeter formula, which shares this loss with other taxing entities, the maximum loss of the Tax Loss Reserve Fund would be \$55,624.10. Accordingly, there should be no direct impact on the County General Fund because reserves exceeding the amount have been set aside.
- More likely than not, there will be minimal impact upon the Tax Loss Reserve Fund itself. Based upon recent experience, this sale will not realize the maximum loss for three reasons: (i) properties are inevitably pulled from the sale due to various reasons including taxpayer redemptions; (ii) some parcels will sell for more than the minimum bid and (iii) other parcels are likely to receive no bids.


Impact on Residents and Businesses

The offering of tax defaulted properties is to collect unpaid taxes and to return the property to a revenue-generating status by conveying the property to another owner or motivating the assessee to redeem.

5 A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE
6 APPROVING SALE OF TAX-DEFAULTED PROPERTY SUBJECT TO THE POWER OF SALE
7 AND SETTING THE MINIMUM BID

8 WHEREAS, the Tax Collector of Riverside County intends to sell at public auction, over the
9 internet, tax-defaulted property subject to the power of sale, on May 17, 2018 through May 22, 2018, and
10 requests that the Board of Supervisors of the County of Riverside, State of California approve the intended
11 sale, and any postponement of the sale that may be necessary; the Tax Sale List TC 213 Sale File 4452 is
12 attached herewith as Exhibit "A" and sets forth the property declared tax-defaulted with the year of the tax-
13 default and the assessment number; the notice of the proposed sale will be sent to the State Controller in
14 accordance with Section 3700.5 of the California Revenue and Taxation Code; and

15 WHEREAS, the Tax Collector in his discretion has determined that the property specified in
16 Exhibit "A" attached hereto and incorporated by reference, should be offered for sale on May 17, 2018
17 through May 22, 2018 with the minimum bid to be in accordance with California Revenue and Taxation
18 Code Section 3698.5, and

19 WHEREAS, California Revenue and Taxation Code Section 3698.5 provides that, where
20 property has been offered for sale at least once and no acceptable bids have been received at the prescribed
21 minimum price, the Tax Collector may, in his discretion and with the approval of the Board of Supervisors
22 offer that same property at the same or next scheduled sale at a minimum price that the Tax Collector
23 deems appropriate in light of the most current assessed valuation of that property or any unique
24 circumstance with respect to that property; and

25 WHEREAS, one hundred thirty-five (135) timeshare intervals, or less, will be offered at the
26 tax sale for the first time for the full redemption amount plus cost of sale, and if these timeshare intervals
27 do not receive a bid for the full redemption amount plus cost, they will be reoffered later in the same sale a
28 a reduced bid; and

1 WHEREAS, the Tax Collector has determined that due to unique circumstances that the
2 timeshare intervals that are being offered for the first time may not sell for the full redemption amount plus
3 cost of sale, therefore these intervals should be reoffered at the same sale at a reduced bid: and

4 WHEREAS, it is in the best interests of the State of California, the County of Riverside, and
5 cities, school districts, and special districts for whom the Tax Collector collects taxes, to sell said
6 properties; now, therefore,

7 BE IT RESOLVED, DETERMINED, AND ORDERED by the Board of Supervisors of the
8 County of Riverside, State of California, in regular session assembled on January 23, 2018 that the
9 proposed internet sale of tax-defaulted property subject to the power of sale and any continuation of the
10 sale is hereby approved and the Tax Collector of the County of Riverside is directed to offer the property
11 described in Exhibit "A" attached hereto and incorporated by reference, at public auction to the highest
12 bidder for cash in lawful money of the United States at the minimum bid set in accordance with California
13 Revenue and Taxation Code Section 3698.5(a) and 3698.5(c) as specified below:

14 1. One hundred thirty-five (135) timeshare intervals, or less, will be offered at a
15 minimum bid of the full redemption amount plus the cost of sale on May 17, 2018 at 8:00 a.m. through
16 May 18, 2018 at 9:00 a.m.

17 2. If any of the timeshare intervals do not sell at the full redemption amount plus cost,
18 they will be reoffered later at the same sale on May 18, 2018 at 9:00 a.m. through May 22, 2018 as follows

19 a) Seventy (70) timeshare intervals will be reoffered at a reduced minimum bid
20 of \$800 per timeshare interval;

21 b) Sixty-four (64) timeshare intervals will be reoffered at a reduced minimum
22 bid of \$400 per timeshare interval; and

23 c) One (1) timeshare interval will be reoffered at a reduced minimum bid of
24 taxes only plus cost of sale.
