She also installed beautiful Christmas lighting displays on those same lots, which attracted people from afar to admire and photograph.

Active in the community, Phyllis belonged to the La Quinta Volunteer Fire Department Firebelles and the Indian Springs Women's Golf Club. She volunteered for Martha's Kitchen and at an orphanage in Mexico. She worked with Sister Gabi Williams in the Coachella Valley to promote youth education, assisting immigrants and the needy.
