BACKGROUND:

Summary

The Riverside County Advisory Council on Aging is the official Local Area Advisory Council, as mandated by the Federal Older Americans Act and the State Older Californians Act. The council is a volunteer leadership body, composed of seventeen (17) members, advising the Board of Supervisors (Board) and the Office on Aging on matters related to development of the Office on Aging Strategic Plan, administration of the plan and operations conducted under the plan.

Pursuant to Resolution #2005-148, Uniform Rules and Procedures for Advisory Committees, Boards and Commissions of the County of Riverside and in accordance with Board Policy A-21, the Office on Aging and the Advisory Council on Aging respectfully request the Board appoint new member Edward Greaves to the Advisory Council on Aging, with a term expiring June 30, 2021.

The council conducted an extensive search throughout the County and an intensive screening and interview process to replace a vacant Council position.

Member Name and Term:

Edward Greaves was selected by the Riverside County Advisory Council on Aging committee to replace Ann Kasper, who vacated the position in May 2017. Mr. Greaves' term will expire June 30, 2021.
