BACKGROUND:

Summary

On June 16, 2015, Item 3-22, the Board of Supervisors (Board) approved the construction contract between the County of Riverside and Enko through the use of the Easy Indefinite Quantity Construction (EZIQC) contract in the amount of \$604,100, for the ECEOC Phase II project to install a new audio and visual system. During construction, three change orders were approved in the cumulative amount of \$34,246, increasing the contract value to \$638,346. The three change orders did not exceed the 10% contingency allowance nor single change order dollar authority; therefore no Board action was required.

Enko has completed the work to the project, and has been inspected and found to comply with the contract requirements. This Board action will release the undisputed contract retention funds in the amount of \$31,917 to Enko after the Notice of Completion has been recorded and the 35 day lien period has expired per contract terms.

Impact on Residents and Businesses

There are no negative impacts to residents or businesses; the new audio and visual equipment at the ECEOC has enhanced the response to natural disasters and other emergency situations by the County's Emergency Management Department.

Additional Fiscal Information

All costs associated with this Board action were previously approved on June 16, 2015 (Item 3-22) and are 100% funded through existing JJB Detention Center Bond Proceeds.


