

BACKGROUND:

Summary

The District, in partnership with the City of Norco, is proposing to construct and maintain the project. The primary project objective is to alleviate the flooding and debris buildup currently experienced by the community after a moderate storm. The project includes 3,250 lineal feet of underground storm drain and a small debris basin.


Pursuant to Section 15282(k) of the CEQA Guidelines, construction of new pipeline and demolition of existing pipeline is statutorily exempt from CEQA as long as the project does not exceed one mile in length. Additionally, Section 15304 of the State CEQA Guidelines exempts minor alterations to land such as grading on land with a slope of less than 10%. Furthermore, based on the environmental analysis that has been conducted, the project would not result in adverse impacts. As such, in accordance with CEQA a Notice of Exemption has been prepared by the District and should be filed with the County Clerk no more than five days after the date of the project approval.

Impact on Residents and Businesses

Improved flood protection and public safety in the project vicinity.

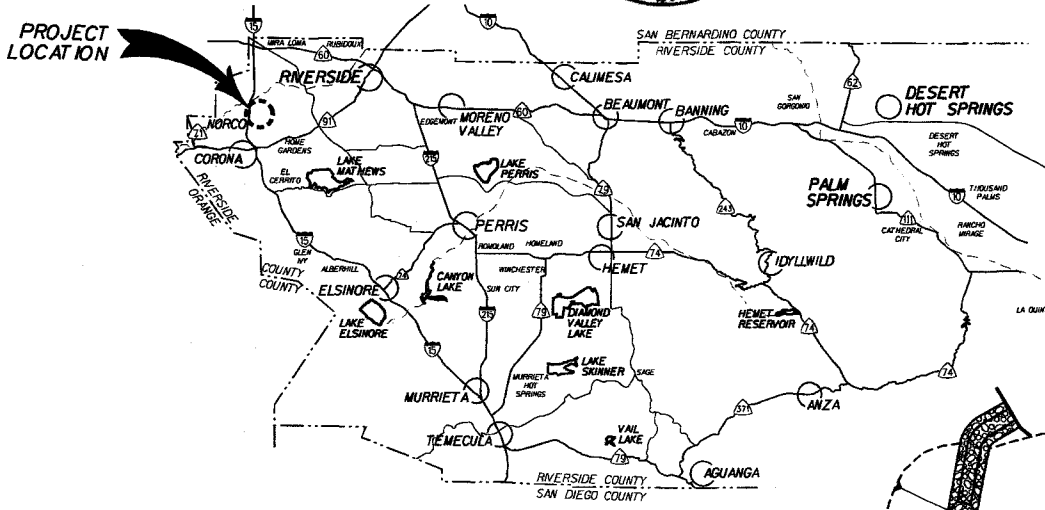

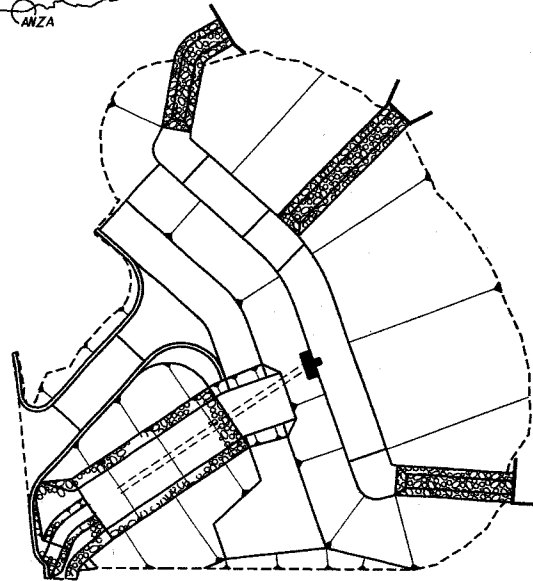
Exhibit 1 Project Location and Vicinity Map



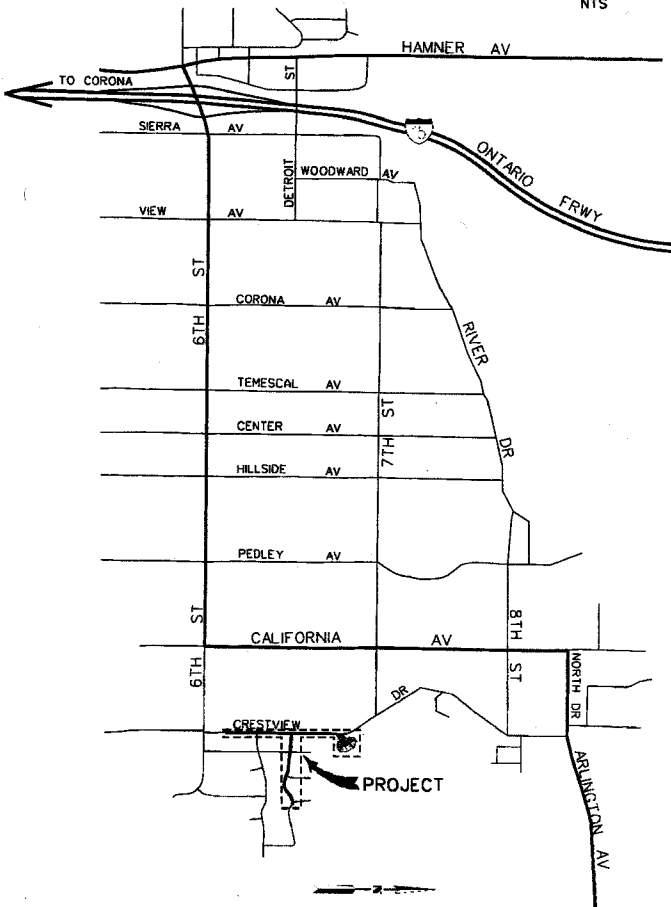
Norco MDP Line NA-1, Stage 2 and Lateral NA-1A, Stage 1



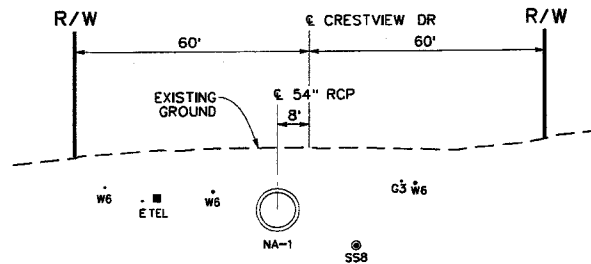
VICINITY MAP

DEBRIS BASIN

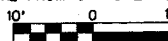


INDEX MAP

ENGINEER'S STATEMENT

The proposed Norco MDP Line NA-1, Stage 2 and Norco MDP Lateral NA-1A, Stage 1 project is located within the city of Norco in the neighborhoods surrounding the intersection of Crestview Drive and Mt. Rushmore Drive, at the foot of the La Sierra Hills. The primary project objective, as defined in the approved project charter, is to alleviate the flooding and debris buildup currently experienced by the community after a moderate storm. The project includes the construction of a storm drain system which will collect and convey runoff from the La Sierra Hills and help relieve the community of flooding issues for the 10-year storm event. The project also includes the construction of a small debris basin to reduce the amount of mud/debris laden flows through the community.

The cost of the proposed project is approximately \$3,000,000.



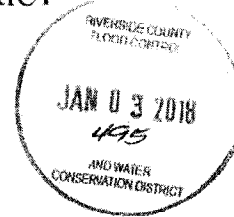

CDFW imposes and collects a filing fee to defray the costs of managing and protecting California's vast fish and wildlife resources, including, but not limited to, consulting with other public agencies, reviewing environmental documents, recommending mitigation measures, and developing monitoring programs.

Annual Fee Adjustments

Payment of Fees

Filing Fees are due at the time a Notice of Determination is filed with the county clerk's office (local lead agency), or with the State Clearinghouse (state lead agency). Fees due for Certified Regulatory Program (/Conservation/CEQA/Procedures/Commission) notices are due to CDFW directly and before the respective Notice of Decision is filed with the Secretary for Natural Resources.

Exemptions and No Effect Determinations

The CEQA filing fee will be waived if a project will have no effect (/Conservation/CEQA/NED) on fish and wildlife (Fish & G. Code, § 711.4, subd. (c)(2)(A)). Additionally, projects that are statutorily or categorically exempt from CEQA are also not subject to the filing fee and do not require a no effect determination (Cal. Code Regs., tit. 14, §§ 15260-15333; Fish & G. Code, § 711.4, subd. (d)(1)). Only CDFW staff is responsible for determining whether a project will qualify for a No Effect Determination and if the CEQA filing fee will be waived.





BACKGROUND:

Summary

Section 18 of the District Act requires the Board of Supervisors to hold a public hearing for the purpose of considering all comments regarding proposed facilities before authorizing construction of such facilities.

The Riverside County Flood Control and Water Conservation District (District) in partnership with the City of Norco, is proposing to construct and maintain the project. The primary project objective is to alleviate the flooding and debris buildup currently experienced by the community after a moderate storm. The project includes 3,250 lineal feet of underground storm drain and a small debris basin.

Pursuant to Section 15282(k) of the California Environmental Quality Act ("CEQA") Guidelines, construction of new pipeline and demolition of existing pipeline that does not exceed one (1) mile in length is statutorily exempt from CEQA. Additionally, Section 15304 of the State CEQA Guidelines exempts minor alterations to land such as grading on land with a slope of less than 10%. Furthermore, based on the environmental analysis that has been conducted, the project would not result in any adverse impacts to any environmental resources. As such, in accordance with CEQA a Notice of Exemption has been prepared and the Clerk of the Board will file the Notice of Exemption within five (5) days of the Board approving the project if said project is approved at the February 27, 2018 Board of Supervisors meeting.

Impact on Residents and Businesses

Improved flood protection and public safety in the project vicinity.
