BACKGROUND:

Summary

On August 29, 2017, the Board awarded Road Builders, Inc. the contract for the Construction of Slope Remediation at the Lamb Canyon Sanitary Landfill (Item 12C-3; MO# 5134). The total contract amount was \$475,247.50.

On December 10, 2017, construction of this project was satisfactorily completed on time and within budget. The Department has accepted the work; therefore, the Department recommends filing a Notice of Completion. The final cost for the project is \$468,114.90, which is approximately 1.5% under the authorized budget.

This Board action will allow for release of retention funds in the amount of \$23,405.75 to Road Builders, Inc., after the lien period has expired.

Impact on Residents and Businesses

This project stabilized the slope failure at Lamb Canyon landfill that occurred due to the heavy rainstorm events in January 2017. In addition, various preventative measures were implemented during this project to ensure the safe operation of the landfill and compliance with the applicable regulations.

Additional Fiscal Information

This is an administrative action to file the Notice of Completion and no additional funds are being requested.

Contract History and Price Reasonableness

The total final contract cost is approximately 1.5% under the authorized budget for this project which was originally competitively awarded, with Road Builders, Inc. submitting the lowest bid out of six (6) bids received.


