"Bill" Rich, a native of Riverside, California who passed away on February 17, 2018, just a few months shy of his 90th birthday.

Rising from paperboy to publisher at The Press-Enterprise, Bill began his 52-year career as a substitute newspaper carrier in 1941 and continued with his own route a year later. He later joined the newspaper as a circulation district manager and was eventually promoted to circulation director. Bill continued to work his way up the ranks until he became publisher and general manager in 1989. When Bill retired in 1993, he was the newspaper's longest-tenured employee.

During Bill's career, the newspaper's circulation rose from 12,000 to 157,000 and, at its peak, had a staff of 1,300. Remembered as the best supervisor in the world, he influenced many people through his leadership, encouragement, and support.

Bill was active in several community organizations. He was past president of the Riverside Area United Way and past chairman of the Economic Development Partnership and the Riverside County Chapter of the American Red Cross. He was also a member of the Monday Morning Group and the Kiwanis Club of Riverside. During a one-year break from his newspaper career, he proudly served in the U.S. Army during the Korean War.

Bill was a loving and devoted husband, father, grandfather, great-grandfather, mentor, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.

A dedicated public servant, Deputy Norma Sandoval worked for the Riverside Sheriff's Department for 11 years. She sought to serve her community by protecting those who could not protect themselves and to make a difference in the lives of every community member she came across.

After obtaining a Bachelor's Degree from the University of California-Irvine, Deputy Sandoval began her career in law enforcement with the United States Border Patrol in 2003. In June 2006, she joined the Riverside County Sheriff's Department. She was assigned to the Robert Presley Detention Center after graduating from the RSO Academy.

In October 2008, Deputy Sandoval was transferred to the Perris Station and assigned to Patrol Operations. She quickly caught the attention of her supervisors as being an outstanding law enforcement officer. As a result, she was selected to be a field-training officer and trained several new deputies. She excelled as a field-training officer and received praise from her trainees, peers, and supervisors.

Due to her success as a field-training officer and mentor, Deputy Sandoval was assigned to the Ben Clark Training Center as a drill instructor for the Sheriff's Basic Academy in June 2012. She excelled in this position and received accolades from her supervisors and the community. She was then assigned to the Perris Gang Task Force where she excelled as well. She was also an excellent marksman and finished near the top of a task force target shooting competition.

Deputy Sandoval will always be remembered as an outstanding deputy sheriff, an incredible beat partner, a heartwarming friend, and a loving wife and mother. She is survived by her husband Deputy Alberto Pulido and her two sons Johnny Gonzalez Sandoval and Albert Michael Pulido; her sisters Elizabeth, Jenny, and Elvia; and her brother Ernest Sandoval.

Born on October 7, 1940 in a small farmhouse in Orchard, Nebraska, Bob's education began in a small public school in Tecumseh, where he attended kindergarten through the eleventh grade. His family then moved to San Diego, California, where he attended St. Augustine High School, a Catholic, all boys' school. After graduating from high school, he received an athletics scholarship from the University of Oregon, where he attended from 1958 to 1959. He then transferred to Lower Columbia, Washington in 1959. From 1959 to 1960, he attended Chaffey College in California. From 1960 to 1964, he attended Long Beach State, where he earned his Bachelor of Arts Degree in Physical Education in 1964. He earned his Master's Degree in Physical Education from Azusa Pacific College in 1973.

Bob began his successful coaching career as an assistant coach at Cantwell High School from 1964 to 1967. He then accepted a teaching/coaching position from 1967 to 1972 at Notre Dame High School in Riverside, California and led them to a CIF title in 1970. In 1973, he accepted a coaching position at Sunnyvale High School. From 1974 to 1999, Bob served as the head football coach at Mt. San Jacinto College. During his tenure, he was named Conference Coach of the year seven times and Region III Coach of the Year three times. In 1998, he was named State Coach of the Year.

When Bob retired after the 1999 season, the Eagles were ninth in the nation and fourth in the state in the power rankings. He was added to the State Coaches' Hall of Fame, and in 2010, was inducted into the inaugural MSJC Hall of Fame. In 2013, the Hemet Sportsman's Club created a "Stangel Trophy" award that is presented annually to the San Jacinto Valley's top senior football player. He dedicated many service hours to his coaching profession by serving as the California Community College football Coaches Association Membership Chairman/Treasurer from 1975 to 2011. In 1998, he was named the CCCFCA State Coach of the year, and in 2003, he was inducted into the Hall of Fame.

A loving and devoted husband, father, grandfather, mentor, and friend, Bob was preceded in death by his wife Elaine in November 2017. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.

Born in 1925 in Los Angeles, California, Fred was a proud veteran of Guadalcanal and served 41 years with Los Angeles Police Department, LAX Los Angeles Airport, and the Los Angeles Harbor Police Forces. Known to his friends and family as "The Fox," his life was defined in both service to his country and society.

After the attack on Pearl Harbor, Fred enlisted in the U.S. Navy at the age of 17. He was sent to Guadalcanal, where he earned a Purple Heart when his ship was blown in half and sunk by a Japanese torpedo plane. He spent the next few years in the Pacific Theater earning several combat citations. He also documented much of the experience as a photographer capturing images not just of the war but also the island natives who tried to live in peace.

When he returned home, Fred served in the U.S. Air National Guard, married his high school sweetheart, Carol "Slim" Myers, and took a job at Warner Bros. Studios. He was then hired on to the LAPD beginning his life-long career in law enforcement. After 25 years with LAPD, he became the top law enforcement officer at LAX International Airport, where he redefined airport security and put in place security innovations that are still the standard today. He then became the Chief and Port Warden of World Port Los Angeles, where he worked to modernize the joint task force that would later become part of the first line of defense against terrorism.

After he retired, Fred moved to Sun Lakes, California, where he volunteered to serve on the Banning Police and Fire Commission. He was a member of the American Legion, Elks Lodge Beaumont, Rotary Club, The Sun Lakes Arts League, International Culture Club, The Golf Club, The Big Band Dance Club, and was part of the cast of The Sun Lakes Follies for several years. He also donated to several charities including, The United States Coast Guard Foundation, The Humane Society, Paralyzed Veterans Of America, and The Make The World A Better Place Foundation.
