

BACKGROUND: Community Improvement Designation funds will be allocated to the following organizations:

Riverside County District Attorney's Office, Division of Victim Services - \$1,000 funding will be used to support outreach and awareness to the public by hosting events throughout the County for National Crime Victims' Rights Week.

Riverside County School Boards Association - \$1,000 funding will be used to support the Annual Education Symposium. The purpose of the symposium is to prepare 12th grade foster youth who will be aging out of the foster care system.

Canyon Lake Women's Club - \$1,000 funding will be used to support their Scholarship Program which will award scholarships to Canyon Lake female residents who are currently in their senior year of high school.

Operation Prom Girl Southern California - \$1,500 funding will be used to support efforts to provide dresses to local high school girls that are going through hardships or circumstances which leave them unable to purchase a formal dress and accessories to attend their prom. One hundred girls have signed up for assistance this year.
