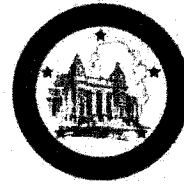



**BACKGROUND:**

**Summary**

On October 13, 2007, Assembly Bill 1168 adding Article 3.5 to Chapter 6 of Part 3 of Division 2 of Title 3 to the California Government Code commencing with Section 27300, known as the Social Security Number Truncation Program (SSNTP), was approved. It required the County Recorder to establish a SSNTP to protect against the risk of identity theft.

The SSNTP required the County Recorder, for each official record recorded between January 1, 1980 and December 31, 2008, to create, in an electronic format, a public record version of the official record, truncating any social security number contained in that official record.

In addition, the SSNTP requires the County Recorder, for each official record recorded on or after January 1, 2009, to create, in an electronic format, a public record version of the official record, truncating any social security number contained in that official record.

Government Code Section 27361(d)(1) allowed the County Recorder, in addition to other authorized fees, to charge a fee of one dollar (\$1.00) for recording the first page of every instrument, paper, or notice required or permitted by law to be recorded when authorized by the County Board of Supervisors. This fee could only be used by the County Recorder for the purpose of implementing the SSNTP.

On February 26, 2008, in agenda item 9-4, the Board of Supervisors adopted Ordinance No. 877, entitled "An Ordinance of the County of Riverside Establishing a Recording Fee Under the Social Security Number Truncation Program," and Resolution No. 2008-093, entitled "Resolution of the Riverside County Board of Supervisors Authorizing the County Recorder to Charge an Additional Fee for Implementation and Ongoing Operation of the Social Security Truncation Program and to Require the Auditor-Controller to Conduct Reviews," which authorized the County Recorder to begin collecting this fee in order to fund the SSNTP.

Pursuant to Government Code Section 27361(d)(2), this fee can no longer be charged after December 31, 2017 unless reauthorized by the County Board of Supervisors. Such reauthorization by the Board must take place between June 1, 2017 and December 31, 2017.

**SUBMITTAL TO THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE,  
STATE OF CALIFORNIA**

When the Board authorized this fee, pursuant to Government Code Section 27361(d)(4), the Board required the County Auditor to conduct two reviews to verify that the funds generated by the fee were being used for the implementation of the SSNTP. The first review was completed between June 1, 2012 and December 31, 2013. The second review was completed between June 1, 2017 and December 31, 2017.

After the second review, the County Recorder and Auditor Controller determined that the implementation of the SSNTP has been paid for and the fee is no longer necessary to cover the ongoing costs of the County Recorder in complying with the SSNTP. Thus, the County Recorder decided not to seek reauthorization by the Board of Supervisors in order to continue collecting this fee.

On February 27, 2018, in agenda item 3-10, The Board of Supervisors introduced Ordinance No. 877.1. Ordinance No. 877.1 repeals Ordinance No. 877 in its entirety, and shall take effect thirty (30) days after its adoption.

Thus, it is recommended that the Board of Supervisors adopt, read title and waive further reading of Ordinance No. 877.1, and rescind Resolution No. 2008-093.

**Impact on Citizens and Businesses**

The termination of the SSNTP fee will assist Riverside County citizens and businesses by reducing the cost to record an instrument.

**SUPPLEMENTAL**

**Additional Fiscal Information**

This will not impact the overall revenue significantly as the fee collected under Ordinance No 877 could only be used by the County Recorder for the purpose of implementing the SSNTP. Upon review, the County Recorder and Auditor Controller determined that the implementation of the SSNTP has been paid for and collecting the fee is no longer necessary to cover the ongoing costs of the County Recorder in complying with the SSNTP. The existing SSNTP fund, in conjunction with the digital recording system utilized by the County Clerk-Recorder is sufficient to support the truncation of social security numbers for all electronically maintained recorded instruments.



The Board of Supervisors of the County of Riverside ordains as follows:


