

**BACKGROUND:**

**Summary**

Ordinance 849.1 was adopted by the Riverside County Board of Supervisors on March 2, 2010, to collect the cost of support for minors in local juvenile institutions, minors housed at the Division of Juvenile Justice and the clothing cost for juveniles in group homes. The Ordinance provided authority in establishing and collecting Juvenile Probation fees by designating county staff to evaluate a family's ability to pay those fees and to determine the appropriate amount based on that assessment. SB 190 was signed by the Governor on October 11, 2017, with an effective date of January 1, 2018, and repeals a County Board's authority to establish, assess and collect fees associated with adjudicating, detaining and supervising youth in the criminal justice system. SB 190 requires counties to end the assessment of all juvenile fees, but it does not prohibit the collection of previously assessed juvenile fees. SB 190 does not change a county's ability to collect restitution on behalf of crime victims, or to charge restitution fines.

**Impact on Residents and Businesses**


Residents of Riverside County will no longer be charged specified fees for a youth's involvement in the juvenile delinquency system.

**Additional Fiscal Information**

The Superior Court of California Enhanced Collections Division (ECD) currently collects all fees on behalf of the Probation Department. Based on preliminary estimates received from the ECD, Riverside County has approximately \$11 million in outstanding juvenile fees. The Probation department has recommended that the courts continue to collect on previously assessed juvenile fees with the hope of recouping at least a portion of the outstanding debt. The department previously collected approximately \$350,000 per year in juvenile related fees. Prospectively, this revenue will no longer be available to the department.




