#### **BACKGROUND:**

#### **Summary**

Change of Zone No. 7818 (CZ 7818) changes the property's zoning from Rural Residential (R-R) to General Commercial (C-1/C-P) on approximately 3.5 acres.

The public hearing on CZ 7818 was held on October 20, 2015, as Agenda Item 16-1. At the conclusion of the public testimony, the Board of Supervisors closed the public hearing, adopted a Negative Declaration for Environmental Assessment No. 41706 and tentatively approved CZ 7818. Pursuant to Section 4.1 of Ordinance No. 348, the County's unincorporated area is placed in mapped zoning districts. Adoption of Ordinance No. 348.4826 will finalize the Board's tentative action on CZ 7818, formally change the property's zoning classification and amend the County's zoning map to reflect the new zoning classification.

CZ 7818 is associated with General Plan Amendment No. 903 (GPA No. 903). On March 29, 2016, GPA No. 903 received final approval with the adoption of Resolution No. 2016-098. On April 28, 2016, a legal challenge was filed, *Residents for Intelligent Planning v. County of Riverside*, Riverside Superior Court Case No. RIC1605168, which challenged GPA No. 903, the prospective change of zone, and the Negative Declaration under the California Environmental Quality Act. A Settlement and Release Agreement, to which the County was not a party, for that case was executed in or around December 2017, after which a Notice of Conditional Settlement was filed.

With the final approval of GPA No. 903 and the execution of the Settlement and Release Agreement, CZ 7818 may move forward for final approval with the adoption of Ordinance No. 348.4826. The opportunity for public review and comment was provided during the public hearings scheduled for this change of zone and any verbal or written testimony provided by the public was considered by the hearing body at that time. This action will finalize the Board of Supervisors tentative action on the change of zone that was taken on October 20, 2015.

The subject site is located northwesterly of Highway 79, east of Pourroy Road, and south of Keller Road as shown on the attached maps entitled "Vicinity/Policy Area" and "Proposed Zoning."

Today's action will finalize the Board's tentative action that was taken on October 20, 2015, pursuant to Agenda Item No. 16-1 and formally change the property's zoning classification.

There is no fiscal impact to the County because the cost for processing Change of Zone No. 7816 has been borne by the applicant.




