BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the April 10, 2018 City of Rancho Mirage General Municipal Mail Ballot Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On March 13, 2018, the Board of Supervisors approved the conduct of election services for the City of Rancho Mirage. Election costs fully reimbursable from the City of Rancho Mirage are approximately \$24,700.

The election was held on April 10, 2018 with about 52% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the City of Rancho Mirage General Municipal Mail Ballot Election.

Impact on Residents and Businesses

Registered voters who reside in the City of Rancho Mirage had the opportunity to elect three City Councilmembers.

Additional Fiscal Information

As approved by the Board of Supervisors on March 13, 2018, local jurisdictions will reimburse the Registrar of Voters for the full cost of conducting their election.


