- 2. Authorize the Purchasing Agent, in accordance with Ordinance 459, based upon the availability of funding and as approved by County Counsel to: a) to execute BPO Agreements with the vendors listed in Attachment A; b) exempt the Purchasing Agent from the sole source requirement when adding new vendors not to exceed \$100,000 without securing competitive bids while staying within the approved aggregate amount; c) shift the allocated funds among the vendors listed in Attachment A; d) sign renewals and amendments that do not change the substantive terms of the agreement, including amendments to the compensation provisions that do not exceed 10% of the aggregate amount of \$500,000 through June 30, 2023.

BACKGROUND:

Summary

Riverside University Health System - Behavioral Health (RUHS-BH) operates a continuum of care system that consists of County-operated and contracted service providers delivering a variety of mental health treatment services within each geographic region of Riverside County.

Licensed Board and Care facilities are less restrictive and less intensive licensed residential level of care for behavioral health clients. The purpose of this level of care is to provide eligible adult clients with supervised and structured residential services including supported programs resulting in the transition of clients into independent living. RUHS-BH only utilizes licensed Board and Care facilities that are in good standing with the California Department of Social Services (CDSS). Placement in these facilities is determined upon client need, location and availability of beds.

On May 19, 2015, (3-16), the Board authorized the Riverside County Purchasing Agent to execute BPO agreements with licensed Board and Care facilities for a combined aggregate amount of \$500,000 through June 30, 2018. RUHS-BH is requesting that the Board authorize the County Purchasing agent to execute BPO Agreements under Board Policy A-18 for Board and Care facilities effective July 1, 2018 through June 30, 2019 with the vendors listed in Attachment A for \$500,000 and renew annually through June 30, 2023.

Impact on Citizens and Businesses

These services are a component of the Department's system of care aimed at improving the health and safety of consumers and the community.

Additional Fiscal Information

RUHS-BH provides reimbursement to Board and Cares when a client is indigent or awaiting approval of Social Security Disability benefits. When benefits are received, Social Security Administration reimburses RUHS-BH for the cost incurred. The BPO Agreements contain termination provisions in the event that applicable Federal, State, and/or County funds become unavailable. There are sufficient funds in the Department's FY18/19 budget and no County funds are required.

Contract History and Price Reasonableness

CDSS regulates the rates paid to the Board and Cares. The current rate ranges from \$33.53 to \$37.12 per day, depending on the number of days in the month. RUHS-BH monitors utilization throughout the year to determine the projected BPO amount. Due to the specialized services provided by the vendors listed in Attachment A, RUHS-BH requires the flexibility to add vendors if necessary to ensure continuity of care.
