On motion of Supervisor Perez, seconded by Supervisor Washington, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, May 1, 2018, be adjourned in memory of John Alexander James, Elder and former Chairman of the Cabazon Band of Mission Indians who passed away on April 21, 2018.

Born in 1931, Chairman James spent his early years in the Los Angeles area. He was a Korean War Army Veteran, serving as a member of the "Wolfhounds" 27th Infantry Regiment, 25th Infantry Division. For his courageous service, he received two Bronze Stars and was recognized by President Richard M. Nixon as an Honorary Navajo Code Talker.

Chairman James had a successful career with the telephone company for more than 25 years and showed leadership from an early age. In 1977, he became Secretary/Treasurer of the Cabazon Band of Mission Indians. As he got more involved with tribal government, Chairman James recognized the need for tribal self-sufficiency and saw the establishment of high-stakes bingo and poker as a means of achieving that goal. His influence led to the landmark 1987 Cabazon decision in the U.S. Supreme Court, affirming the inherent right of The Cabazon Band of Mission Indians and other sovereign tribes across the country to set the course for their own futures and consequently, creating the Indian gaming industry in the United States.

Chairman James was elected into office as Chairman of the Cabazon Band of Mission Indians in 1989, serving in that position for over 20 years. He received many tributes including the National Indian Gaming Association's John Kieffer Sovereignty Award. In 2008, he was honored with the Pathbreaker Award by the Indian Gaming Regulatory Act Conference. He also received a plaque in 2016 at the Veterans Memorial Park in Coachella.

Chairman James will be greatly missed but never forgotten. His memory and passionate spirit will live forever in the hearts of those who knew and loved him.
