BACKGROUND:

Summary

The Board of Supervisors of the County of Riverside (County) is asked to adopt a resolution which would approve the issuance of private activity bonds by the California Enterprise Development Finance Authority (the Authority) for the purpose of financing and refinancing the acquisition, construction, expansion, and renovation of, and equipping of facilities to be used for the benefit of Family Service Association Community Housing Development Organization (FSA), Inc. FSA will continue to operate the facilities that these bond proceeds are intended for in connection with its mission of providing quality human services, child development, housing and senior services to residents of the County of Riverside. FSA have requested that the Authority participate in the issuance of one or more series of revenue bonds in an aggregate principal amount not to exceed \$2,500,000 (the Bonds) the proceeds of which will be used to: (a) finance and/or refinance the cost of acquisition, construction, installation, equipping and furnishing an approximately 7,096 square foot child care facility on approximately a 47,480 square foot lot located at 24693 Ironwood, Moreno Valley, California 92557, an approximately 8,130 square foot child care facility on approximately a 34,412 square foot lot located at 41931 E. Florida Avenue, Hemet, California 92544, and an approximately 4,094 square foot community services facility approximately a 25,265 square foot lot located at 5317 Mission Boulevard, Jurupa Valley, California 92509, consisting of community service space, offices, storage and parking; and (b) pay capitalized interest and certain costs of issuance incurred in connection with the issuance of the bonds.

The Internal Revenue Code of 1986 (the Code) requires that the "applicable elected representatives" of the jurisdiction in which a project is to be financed with "private activity bonds" is situated, adopt a resolution approving the issuance of such "private activity bonds" after a public hearing has been held which has been noticed in a newspaper of general circulation in such jurisdiction. On May 22, 2018 the Board of Supervisors of the County of Riverside will hold such public hearing which was noticed as required by the Code. The proposed resolution will act as the approval by the "applicable elected representatives" with respect to the proposed project.

The County will not be a party to the financing documents. As set forth in the Associate Membership Agreement, dated April 17, 2007, the debt will not be secured by any form of

taxation, or by any obligation of either the County or the Authority. Neither would the debt represent or constitute a general obligation of either the County or the Authority. Pursuant to the governing California statutes and the Associate Membership Agreement, a member or associate member of the Authority is not responsible for the repayment of obligations incurred by the Authority. The debt would be payable solely from amount received pursuant to the terms and provisions of financing agreements to be executed by FSA d/b/a Aspire Community Housing Organization or one or more affiliates

County Counsel has reviewed and approved the attached Resolution. Staff recommends approval of Resolution No 2018-091.

Impact on Residents and Businesses

The issuance of the bond will provide FSA and its affiliates with the funding needed to continue managing much needed services for the residents living in the County of Riverside.

Additional Fiscal Information

The County's membership in the Authority bears with it no cost or other financing obligation, but serves as a public acknowledgment by the host jurisdiction of the project financing.

13 **WHEREAS**, Family Service Association, a California nonprofit public benefit corporation, d/b/a
14 Aspire Community Housing Organization (the "Borrower"), has submitted and the California Enterprise
15 Development Authority (the "Authority") has accepted, an application requesting the Authority to issue, from
16 time to time, pursuant to a plan of finance, its tax-exempt and/or taxable revenue obligations in an aggregate
17 principal amount not to exceed \$2,500,000 (the "Obligations") for the benefit of the Borrower pursuant to
18 Chapter 5 of Division 7 of Title 1 of the Government Code of the State, (commencing with Section 6500) (the
19 "Act") the proceeds of which will be used in part to (a) finance and/or refinance the cost of acquisition,
20 construction, installation, equipping and furnishing an approximately 7,096 square foot child care facility on
21 approximately a 47,480 square foot lot located at 24693 Ironwood, Moreno Valley, California 92557, and
22 approximately 8,130 square foot child care facility on approximately a 34,412 square foot lot located at 41931
23 E. Florida Avenue, Hemet, California 92544, and an approximately 4,094 square foot community services
24 facility approximately a 25,265 square foot lot located at 5317 Mission Boulevard, Jurupa Valley, California
25 92509, consisting of community service space, offices, storage and parking, in each case together with all
26 necessary ancillary facilities (together, the "Facilities"); and (b) pay capitalized interest and certain costs of
27 issuance in connection with the Obligations; and

28 **WHEREAS**, the issuance of the Obligations must be approved by the governmental unit on behalf of

1 which the Obligations are issued and a governmental unit having jurisdiction over the territorial limits in which
2 the Facilities are located pursuant to the public approval requirement of Section 147(f) of the Internal Revenue
3 Code of 1986, as amended (the "Code"); and

4 **WHEREAS**, the Facilities are located within the territorial limits of County of Riverside (the "County")
5 and the Board of Supervisors of the County (the "Board of Supervisors") is the elected legislative body of the
6 County; and

7 **WHEREAS**, pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code"), the
8 issuance of the Bonds by the Issuer must be approved by the County because the Facilities are located within
9 the territorial limits of the County; and

10 **WHEREAS**, the Issuer has requested that the Board of Supervisors approve the issuance of the
11 Obligations by the Issuer for the financing and refinancing of the Facilities in order to satisfy the public
12 approval requirement of Section 147(f) of the Code; and

13 **WHEREAS**, the Issuer's issuance of the Bonds will result in a more economical and efficient
14 issuance process because of the Issuer's expertise in the issuance of conduit revenue bonds; and

15 **WHEREAS**, it is intended that this Resolution shall comply with the public approval requirements
16 of Section 147(f) of the Code; provided, however, that this Resolution is neither intended to nor shall it
17 constitute an approval of the Facilities by the Board of Supervisors for any other purpose; and

18 **WHEREAS**, a public hearing was held by the County on the 22nd day of May, 2018, at the meeting
19 which commenced at the hour of 9:00 a.m., in the Chambers of the Board of Supervisors, 4080 Lemon Street,
20 5th Floor, Riverside, California 92501, following duly published notice thereof in a newspaper of general
21 circulation in the County, and all persons desiring to be heard have been heard;

22 **NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED** by the Board of
23 Supervisors of the County of Riverside, assembled in regular session, at the conclusion of the public hearing,
24 on May 22, 2018, at 9:00 a.m. or soon thereafter, in the meeting room of the Board of Supervisors, located
25 on the first floor of the County Administrative Center, 4080 Lemon Street, Riverside, California, the
26 following:

27 Section 1. The foregoing resolutions are true and correct.

28 Section 2. The Board of Supervisors, as the elected legislative body of the County, hereby approves

1 the issuance of the Bonds by the Issuer. It is the purpose and intent of the Board of Supervisors that this
2 resolution constitute approval of the issuance of the Bonds by the “applicable elected representative” of the
3 governmental unit having jurisdiction over the area in which the Facilities are located in accordance with
4 Section 147(f) of the Code; *provided, however*, that this Resolution shall not constitute an approval of the
5 Facilities by the Board of Supervisors for any other purpose.

6 Section 3. The issuance of the Bonds shall be subject to the approval of the Authority of all financing
7 documents relating thereto to which the Authority is a party. The County shall have no responsibility or
8 liability whatsoever with respect to the Bonds.

9 Section 4. The adoption of this Resolution shall not obligate the County or any department thereof to
10 (i) provide any financing to acquire or rehabilitate the Project; (ii) approve any application or request for or
11 take any other action in connection with any planning approval, permit or other action necessary for the
12 acquisition, rehabilitation or operation of the Project; (iii) make any contribution or advance any funds
13 whatsoever to the Authority; or (iv) take any further action with respect to the Authority or its membership
14 therein.

15 Section 5. The officers of the County are hereby authorized and directed, jointly and severally, to do
16 any and all things and to execute and deliver any and all documents which they deem necessary or advisable
17 in order to carry out, give effect to and comply with the terms and intent of this resolution and the financing
18 transaction approved hereby.

19 Section 6. This resolution shall take effect immediately upon its adoption.







**NOTICE OF PUBLIC HEARING
REGARDING THE ISSUANCE OF REVENUE BONDS**

NOTICE IS HEREBY GIVEN that at 9:00 a.m. on Tuesday, May 22, 2018, or as soon thereafter as the matter may be heard, at the in the Chambers of the Board of Supervisors, 4080 Lemon Street, Riverside, California 92501, the Board of Supervisors of the County of Riverside (the "Board of Supervisors") will conduct a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986 (the "Public Hearing") at which the Board of Supervisors will hear and consider information concerning the issuance, from time to time, pursuant to a plan of finance, of one or more series of tax-exempt and/or taxable obligations by the California Enterprise Development Authority (the "Issuer") in an aggregate principal amount not to exceed Two Million Five Hundred Thousand Dollars (\$2,500,000) (the "Obligations") for the benefit of Family Service Association, a California nonprofit public benefit corporation, and/or a related entity (the "Borrower"). The Issuer will loan the proceeds of the Obligations to the Borrower pursuant to one or more loan agreements (the "Loan Agreement"). The proceeds of the Obligations loaned to the Borrower will be applied to (a) finance and/or refinance the cost of acquisition, construction, installation, equipping and furnishing an approximately 7,096 square foot child care facility on approximately a 47,480 square foot lot located at 24693 Ironwood, Moreno Valley, California 92557, an approximately 8,130 square foot child care facility on approximately a 34,412 square foot lot located at 41931 E. Florida Avenue, Hemet, California 92544, and an approximately 4,094 square foot community services facility approximately a 25,265 square foot lot located at 5317 Mission Boulevard, Jurupa Valley, California 92509, consisting of community service space, offices, storage and parking, in each case together with all necessary ancillary facilities (collectively, the "Facilities"); and (b) pay capitalized interest and certain costs of issuance in connection with the Obligations. The Borrower is an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code") and will own and operate the Facilities in connection with its mission of providing quality human services, child development, housing and senior services to residents of the Inland Empire and Desert Communities, while advocating on behalf of those served by the Borrower.

The Obligations and the obligation to pay principal of and interest thereon and any redemption premium with respect thereto do not constitute indebtedness or an obligation of the Issuer, the State of California or any political subdivision thereof, including the County of Riverside, within the meaning of any constitutional or statutory debt limitation, or a charge against the general credit or taxing powers of any of them. The Obligations shall be a limited obligation of the Authority, payable solely from certain revenues duly pledged therefor and generally representing amounts paid by the Borrower.

Interested persons wishing to express their views on the issuance of the Obligations or on the nature and location of the Facilities proposed to be financed and refinanced may attend the public hearing or, prior to the time of the hearing, submit written comments to the Clerk of the Board of Supervisors of the County of Riverside, 4080 Lemon Street, County Board Chambers, Riverside, California 92501.
