RECOMMENDED MOTION: That the Board of Supervisors:





Kathleen Jurasky, District Manager of the Palm Springs Public Cemetery District recommends that the Board of Trustees terms are extended under the terms of the Public Cemetery District Law section 9000-9093. The California Health & Safety Code Section 9024 (a) provides in part that "*Terms of office commence at noon on the first Monday in January*" which falls on January 7, 2019. Section 9023 also provides that there should be two classes of Trustees based on their terms, with one class having at least two trustees.

The first class of trustees includes William G. Kleindienst and Jan M. Pye. Their terms expire on June 30, 2020 with a recommendation of term extension to expire on January 4, 2021. The second class of trustees include Jane Alcumbrac, Lynn Malloto, and Lenny Pepper. Their terms expire on August 31, 2018 with a recommendation of term extension to expire on January 7, 2019.

The District also recommends re-appointment of Ms. Malloto for a four-year term, commencing January 7, 2019.
