BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Inland Valley Symphony \$2,500 the funding is for the Annual Young Artist Competition held at the Murrieta Mesa High School.
- 2. Operation SafeHouse, Inc. \$2,500 the funding will be utilized to provide immediate counseling and intervention services for variable and multiple needs to reunite the youth with their families.
- 3. Rose Again Foundation \$2,500 the funding will be used to provide emergency services for foster youth. The services include contributing clothing, shoes, school supplies, books and tutoring services.
- 4. Center Against Sexual Assault of Southwest Riverside Co. \$5,000 the funds will pay for a sexual assault nurse examiner for the Hemet Sexual Assault Response Team. The examiner is a nurse who has specialized forensic training in treating sexual assault victims.
