

 - d. Has the YAC member demonstrated any growth?
 - e. What ideas or projects have been contributed to the council?
 - f. Proof of Official Transcripts.
 - g. Two letters of reference (only school personnel will be considered, i.e. academic counselor, teacher or club coordinator)
