- 1. Approve an increase to the FY17/18 Psychiatric Inpatient Hospital Provider Contract Aggregate from \$1,000,000 to \$1,500,000 for the providers listed in Attachment A; and
- 2. Authorize the Purchasing Agent, in accordance with Ordinance 459, based upon the availability of funding and as approved by County Counsel to: a) exempt the Purchasing Agent from the sole source requirement when adding new providers not to exceed \$100,000 without securing competitive bids while staying within the approved aggregate amount; b) move the allocated funds among the providers listed in Attachment A; c) sign renewals and amendments that do not change the substantive terms of the agreement, including amendments to the compensation provisions that do not exceed 10% of the aggregate amount of \$1,500,000 through June 30, 2022.

BACKGROUND:

Summary

As the Mental Health Plan provider for Riverside County, Riverside University Health System – Behavioral Health (RUHS-BH) is required to provide acute psychiatric inpatient hospital services to seriously mentally ill children, adults and older adults. Inpatient hospital services include psychiatric evaluation and treatment services, medication services and discharge planning and coordination geared to stabilize the individual for return to the community.

On January 28, 2014 (3-18), the Board of Supervisors approved the Psychiatric Inpatient Hospital Aggregate and agreements for \$1,000,000 annually through June 30, 2018. RUHS-BH is requesting increasing the aggregate from \$1,000,000 to \$1,500,000 annually due to utilization of inpatient hospital services.

Impact on Citizens and Businesses

These services are a component of the Department's system of care aimed at improving the health and safety of consumers and the community.

Additional Fiscal Information

The Psychiatric Inpatient Hospital Agreements are funded by the State and have termination clauses in the event that State funds become unavailable for service provision. No additional County funds are required.

Contract History and Price Reasonableness

Due to the specialized, highly structured and diverse treatment environments needed to treat RUHS-BH consumers with mental illness, an increase in diverse levels of care, such as those provided by the vendors listed in Attachment A, RUHS-BH requires the flexibility to add vendors for psychiatric inpatient hospital services as needed to ensure continuity of care. Such vendors are subject to providing proof of appropriate certifications, licensing and/or other standard review qualifications.

RUHS-BH uses the Department of Health Care Services rates as its standard for establishing the rates for these providers. Each provider Agreement amount is based on a projected utilization multiplied by the rates listed below.
