- 2. Ratify and authorize the Purchasing Agent to sign the agreement with Recovery Innovations, Inc. for the Desert Adult Residential Treatment (ART) program effective April 1, 2018 through June 30, 2018 for \$241,482 with the option to renew for FY18/19 in the amount of \$1,219,250;
- 3. Approve and authorize the Purchasing Agent to sign the new agreements with Anka Behavioral Health, Inc. for the Desert Crisis Residential Treatment (CRT) program in the amount of \$1,270,201, the West CRT program in the amount of \$1,117,788 and the Mid-County ART program in the amount of \$1,019,779 effective July 1, 2018 through June 30, 2019; and

BACKGROUND:

Summary

Riverside University Health System – Behavioral Health (RUHS-BH) operates a continuum of care system that consists of County-operated and contracted service providers delivering a variety of mental health treatment services within each geographic region of Riverside County.

MHSA CSS funding provides for expansion and transformation of public mental health systems, which includes the following services:

- Crisis Residential Treatment (CRT) Short term residential program that provides an alternative to acute psychiatric hospitalization for clients with persistent mental illness
- Adult Residential Treatment (ART) Long term residential alternative to locked Skilled Nursing Facilities which also serve as a transition from a locked facility to community living
- Integrated Service and Recovery Centers (ISRC) The Integrated Services and Recovery Centers (ISRC) for High Utilizers of Restrictive Settings is intended to provide evidencebased services to individuals who are severely and persistently mentally ill such that they struggle with the need for restrictive residential placement
- Full Service Partnership (FSP) Provide a broad spectrum of intensive wellness and recovery based services for individuals who are homeless, at risk of homelessness, and/or have experienced numerous psychiatric hospitalizations or incarcerations related to their mental health disorder

As a result of RFP #MHARC-201 – Mental Health CRT Program and RFP #MHARC-204 – Mental Health ART Program, RUHS-BH is requesting approval of the new agreements with Recovery Innovations, Inc. and Anka Behavioral Health, Inc., approval to increase the aggregate from \$12,962,758 to \$14,027,182 for FY17/18, and approval of the MHSA CSS annual aggregate for the amounts identified in Attachment A through June 30, 2020.

Impact on Citizens and Businesses

These services are a component of the Department's system of care aimed at improving the health and safety of consumers and the community.

Additional Fiscal Information

The Agreements outlined in Attachment A are funded by MHSA, and have termination clauses in the event that applicable funds become unavailable for service provision. There are sufficient appropriations in RUHS-BH FY17/18 and FY18/19 budgets, and no additional County funds are required.

Contract History and Price Reasonableness

On June 30, 2015 (3-36), the Board of Supervisors approved the MHSA CSS Aggregate of \$10,976,135 annually through June 30, 2017. On May 9, 2017 (3-27), the Board, as a result of Request for Proposal (RFP) #MHARC-195 — Lagos CRT, approved the new agreement with Telecare Corporation and approved increasing the aggregate to \$11,192,905 through June 30, 2018. On July 11, 2017 (3-44), the Board, as a result of MHARC-187 — ISRC-FSP Program for Adults and Transitional Age Youth, approved the new agreements with Oasis Rehabilitation, Inc., Victor Community Support Services and Telecare Corporation and approved increasing the aggregate to \$12,962,758 through June 30, 2018.

On November 11, 2016, RFP #MHARC-201 – Mental Health Crisis Residential Treatment Programs, was released via the Public Purchase website. Notifications were sent to 130 organizations and 5 individuals. RUHS-BH sought qualified organizations to provide CRT services at two facilities, one in the Desert and one in West Region or Mid-County. Organizations had the opportunity to submit proposals for each program and geographic location. Three of the four proposals received were deemed responsive, with two proposals for the Desert and one proposal for West Region. An evaluation committee deemed the lowest responsive/responsible bidder as Anka Behavioral Health, Inc., who is the incumbent, for both Desert and West regions.

On November 21, 2016, RFP #MHARC-204 – Mental Health Adult Residential Treatment Program was released via the Public Purchase website. Notifications were sent to 126 organizations and 5 individuals. RUHS-BH sought qualified organizations to provide ART services at two facilities, one in the Desert and one in West Region or Mid-County. Organizations had the opportunity to submit proposals for each program and geographic location. Two proposals were received for Mid-County and one proposal was received for the Desert. An evaluation committed deemed the lowest responsive/responsible bidders as Anka Behavioral Health, the incumbent, for Mid-County ART and Recovery Innovations, Inc. for the Desert ART, which will be a new service for the Desert region.
