BACKGROUND:

Summary

The Executive Office oversees various agreements with contract attorneys for Indigent Defense. Payments are made on a monthly basis to the Law Offices of Barbara Brand, Juvenile Defense Panel, Criminal Defense Lawyers, Virginia Blumenthal and Brown, White, and Osborn, per the terms of the agreements. In FY 16/17, the payments for June were not properly recorded in the correct fiscal year and were expended in FY 17/18. This resulted in the need for a budget adjustment to cover the May payment for one attorney in the amount of \$146,458 and the June payments for all contracts for the current year. The average monthly cost is \$720,296. The additional \$80,000 will cover any court appointed counsel, expert witnesses, and investigators related to Indigent Defense that may be billed for the month of June.

Impact on Residents and Businesses

The Indigent Defense Program provides legal defense services to the impoverished as directed by the court in criminal, juvenile, and probate matters. Contract attorneys provide assistance when the Public Defender declares a representation conflict.

Additional Fiscal Information

The total request of \$946,754 will cover the cost of one remaining invoice for a contract attorney for the month of May in the amount of \$146,458, the average of \$720,296 for all contract attorneys for the month of June and \$80,000 for any court appointed counsel, expert witnesses or investigators related to Indigent Defense.
