SUBJECT: RIVERSIDE UNIVERSITY HEALTH SYSTEM-MEDICAL CENTER: Ratification and Approval of the First Amendment to the Professional Services Agreement with Advanced Eyecare, A Professional Optometric Group for Optometric Services in Correctional Health Settings, All Districts [Total Cost \$240,000; up to \$24,000 in additional compensation – 100% County General Fund]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Ratify and approve the First Amendment to the Professional Services Agreement with Advanced Eyecare, A Professional Optometric Group for Optometric Services in Correctional Health Settings extending the period of performance for one year, September 1, 2018 through August 31, 2019, with three (3) one-year options to renew; expanding the scope of services to adult detainees; and increasing the maximum compensation amount by \$50,000 annually, for a total maximum compensation amount not to exceed \$60,000 annually, effective July 1, 2018; authorize the Chairman of the Board to sign the amendment on behalf of the County.
2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459 based on the availability of fiscal funding and as approved by County Counsel to a) sign amendments that do not change the substantive terms of the agreement, b) sign amendments that exercise the renewal options, and c) sign amendments to the compensation provisions that do not exceed ten (10) percent annually.

**BACKGROUND:**

**Summary**

On September 1, 2017, the County, on behalf of RUHS, entered into an agreement with Advanced Eyecare to provide optometric services in correctional health settings to juvenile detainees. RUHS requests the Board to ratify and approve the First Amendment to the Personal Services Agreement for Optometric Services in Correctional Health Settings between the County of Riverside and Advanced Eyecare, A Professional Optometric Group, to extend the period of performance for one year, September 1, 2018 through August 31, 2019, and to expand the scope of services to provide optometric services in correctional health settings to adult detainees. This amendment will increase funds by \$50,000 annually, from \$10,000 to \$60,000 annually, effective July 1, 2018.

Advance Eyecare travels to the RUHS correctional facilities and performs optical examinations as well as provides eye ware for the juvenile and adult correctional detainees. Advanced Eyecare has the mobile equipment to perform such services as eye pressure tests and diagnose and prescribe fitted eye glasses.

**Impact on Residents and Businesses**

The ability to provide optometric care in a secured environment reduces the exposure of inmates to the patients awaiting services in the RUHS-Clinics.

**Contract History and Price Reasonableness**

RUHS entered into an agreement on 9/1/18 with Advanced Eye Care for \$10,000 annually with the option to renew for four (4) additional periods, renewable in one-year increments by written amendment; the aggregate amount of the contract was \$50,000. This First Amendment adds adults to the scope of services and will increase the aggregate amount of the contract by \$190,000. Although there are vendors available to provide optometric services, there is only one vendor willing to travel to the correctional facilities to perform optometric services on adult and juvenile detainees. The dollar amounts are reasonable when considering risk involved in servicing these subsets of patients.

**FIRST AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT FOR  
OPTOMETRIC SERVICES IN CORRECTIONAL HEALTH SETTINGS  
BETWEEN COUNTY OF RIVERSIDE AND  
ADVANCED EYECARE, A PROFESSIONAL OPTOMETRIC GROUP**

That certain Professional Services Agreement for Juvenile Optometric Services in Correctional Health Settings (“Agreement”), made and entered into effective September 1, 2017, by and between the COUNTY OF RIVERSIDE (“COUNTY”), a political subdivision of the State of California, on behalf of Riverside University Health System (“RUHS”), and ADVANCED EYECARE, A PROFESSIONAL OPTOMETRIC GROUP (“CONTRACTOR”), a California corporation, is hereby amended as follows:

1. **Title.** The title of the Agreement is hereby amended to read as follows:

“PROFESSIONAL SERVICES AGREEMENT  
for  
OPTOMETRIC SERVICES IN CORRECTIONAL HEALTH SETTINGS  
between  
COUNTY OF RIVERSIDE  
and  
ADVANCED EYECARE, A PROFESSIONAL OPTOMETRIC GROUP”

2. **Period of Performance.** The first sentence of Subsection 2.1 of Section 2. Period of Performance is hereby amended to extend the period of performance for twelve (12) months commencing on September 1, 2018 and continuing through August 31, 2019 as follows:

“This Agreement shall be effective September 1, 2017 and continues in effect through August 31, 2019, with the option to renew for three (3) additional periods, renewable in one year increments by written amendment, unless terminated earlier.”

3. **Compensation.** The second and third sentences of Subsection 3.1 of Section 3. Compensation is hereby amended to increase the maximum compensation amount by \$50,000 annually from \$10,000 annually to \$60,000 annually as follows:

“Maximum payments by COUNTY to CONTRACTOR shall not exceed sixty thousand dollars (\$60,000) annually, including all expenses. When payments reach sixty thousand dollars (\$60,000) annually, CONTRACTOR will have fulfilled its contractual obligation.”


4. **Exhibit A.** EXHIBIT A, SCOPE OF SERVICES, shall be deleted and replaced in its entirety with EXHIBIT A, SCOPE OF SERVICES, attached hereto and incorporated herein.
5. **Exhibit B.** EXHIBIT B, PAYMENT TERMS, shall be deleted and replaced in its entirety with EXHIBIT B, PAYMENT PROVISIONS, attached hereto and incorporated herein.
6. **Miscellaneous.** All other terms and conditions of the Agreement not modified herein shall remain unchanged and in full force and effect.
7. **Effective Date.** This First Amendment to the Agreement shall become effective upon signature of both parties, or July 1, 2018, whichever should come first.





SCOPE OF SERVICES  
ADVANCED EYECARE

---

CONTRACTOR will be responsible for the following routine eye examination consults, tests, and procedures in COUNTY Correctional Health Settings:

- Assessment and diagnosis
- Review of eye, health history, and current medications
- Testing eye motility (Cover test)
- Administering eye pressure testing (Glaucoma Test)
- Conduct gross visual fields (the ability to see an object, usually counting the examiner's fingers, in one's peripheral vision)
- Assessment of eyelids, eyelashes, and surrounding tissues (gross examination/detailed examination with a portable slit lamp bio microscope)
- Extensive evaluation of the cornea, conjunctiva, lens, and anterior chamber using a slit lamp bio microscope
- Eyeglass exam and determination using a portable auto refractor
- Eye care appliance and fitting, if applicable
- Neurological testing (determining pupillary functions usually with a penlight)
- Prescription verification
- Dilated fundus exam (examination of the inside of the eye)
- Annual reviews on Optometrist who render eye care services within a correctional setting
- Statistical data on a monthly basis or upon request

CONTRACTOR shall not conduct more than four (4) site visits at COUNTY Correctional Health Settings per month.

**PAYMENT PROVISIONS  
ADVANCED EYECARE**

- 1.0** This Exhibit B outlines the fees and expenses for the engagement, as outlined in the foregoing Agreement.
- 2.0** CONTRACTOR shall be paid according to the reimbursement rates herein.
- 3.0** Travel or related expenses incurred by CONTRACTOR while performing functions on behalf of COUNTY at the request of COUNTY may be reimbursed in accordance with the procedures and standards set out in Board Policy D-1. The Board Policy D-1 can be found for public access on <http://www.rivcocob.org/boardpolicies/policy-d/POLICY-D01.pdf>.
- 4.0** Maximum payment by COUNTY to CONTRACTOR shall not to exceed sixty thousand dollars (\$60,000) annually, including all expenses.
