BACKGROUND:

Summary

Under this agreement the Sheriff's Department will continue to provide seven Deputy Sheriffs to serve as School Resource Officers (SROs) for the Jurupa Unified School District. All costs for this service will be fully recovered through Board-approved rates. County Counsel has approved the Agreement as to form.

The FY 2018-19 estimated law enforcement estimated cost is \$1,044,470. The Department has included the cost estimate in its budget; therefore, no budget adjustment is necessary. The second year's estimate includes an approximate 5% projected rate increase.

Impact on Residents and Businesses

The Sheriff and the District share common goals that include the provision of programs that address the needs of students at risk. The SRO's serve as a visual deterrent to aberrant behavior and thereby enhance the District's campus control and student protection. All costs will be fully recovered through Board approved contract rates.

LAW ENFORCEMENT SERVICES AGREEMENT BETWEEN THE COUNT. OF RIVERSIDE AND THE JURUPA UNIFIED SCHOOL DISTRICT FOR THE JOUNTY SHERIFF'S PROVISION OF SCHOOL RESOURCE OFFICERS

TIS AGREEMENT is made and entered into by and between the COUNTY OF RIVER DE, a political subdivision of the State of California, on behalf of its Sheriff's Department, herein er "SHERIFF", and the JURUPA UNIFIED SCHOOL DISTRICT, a Special-Purpose Distri, hereinafter "DISTRICT".

WHEREAS, SHERIFF and DISTRICT have identified a need to provide additional law preement among DISTRICT'S school sites; and

WHEREAS, SHERIFF and DISTRICT share common goals that include the provision of programs within DISTRICT's jurisdiction that address the needs of students at risk; and

WHEREAS, SHERIFF and DISTRICT desire to work cooperatively toward these goals by entering into this Agreement to place seven Deputy Sheriffs as School Resource Officers on the DISTRICT campuses as needed to assist in the teaching of police science classes and to be a visual deterrent to aberrant behavior and thereby enhance DISTRICT's campus control and student protection; these positions will hereinafter be referred to as "SROs";

IT IS THEREFORE AGREED AS FOLLOWS:

1. <u>TERM</u> This Agreement shall be effective from July 1, 2018 through June 30, 2020, unless sooner terminated as provided in Paragraph 8.

2. SCOPE OF SERVICES

- A. SHERIFF agrees to provide a total of seven Deputy Sheriffs to serve as SROs. Four SROs will be assigned to the Jurupa Valley High School, Patriot High School, Rubidoux High School and Nueva Vista Continuation High School campuses. Three SROs will be assigned to the Jurupa Middle School, Mira Loma Middle School and Mission Middle School campuses. The duties of SROs may include provision of class presentations on relevant law enforcement issues, patrol of said high and middle school campuses, investigation of crimes, maintenance of order on campus, counseling of students and their parents, and serving as liaisons at elementary and secondary school sites. SROs will also serve a liaison role between the educators employed by the DISTRICT, the School Attendance Review Boards (S.A.R.B.), the Probation Department, and other law enforcement officials, and perform other related duties. It is understood that SROs will be assigned to DISTRICT on a full-time basis. Work hours will normally be 0700 to 1500 hours.
- B. DISTRICT agrees to comply with all reasonable requests of SHERIFF necessary to the performance of SROs' duties under this Agreement. DISTRICT agrees to furnish space at each said high school for use by SROs while performing the above-described services.

- 3. <u>MODIFICATION OF SERVICES</u> No portion of the services or responsibilities of either party described in this Agreement may be eliminated, reduced, or appreciably changed without the mutual written consent of both parties.
- 4. <u>COMPENSATION</u> DISTRICT shall reimburse SHERIFF the full cost of rendering service pursuant to this Agreement. Such cost of services shall be established by the County Board of Supervisors in the form of an hourly rate for an SRO and a mileage rate, and shall include all items of cost and expense to the Sheriff for providing the services hereunder. Total cost to DISTRICT under this Agreement is estimated at \$2,141,000. SHERIFF has based this cost estimate on a projection of service hours and mileage for FY 2018/19 and anticipated contract rate adjustments. Payment for services shall be rendered on a monthly basis upon receipt by DISTRICT of a proper invoice submitted by SHERIFF. DISTRICT will notify County prior to February 1, 2019 of any reduction of services necessary due to lack of funding.

5. VACATION AND HOLIDAY TIME

- A. SROs' vacation time shall not conflict with the schedule of duties mutually developed by DISTRICT and SHERIFF.
- B. Because DISTRICT and SHERIFF holidays may not correspond, holiday time will be taken by SROs in accordance with DISTRICT holidays during the contract period. The excess days shall be taken with reasonable notice to DISTRICT, but shall not conflict with the schedule of duties mutually developed by DISTRICT and SHERIFF.
- 6. <u>ADMINISTRATION AND SUPERVISION</u> SHERIFF (or his designee) shall administer this Agreement and supervise SROs on behalf of the County of Riverside. The Superintendent of DISTRICT (or designee) shall administer this Agreement on behalf of DISTRICT.
- 7. <u>COUNTY EMPLOYEE</u> SROs shall remain employees of SHERIFF on special assignment to DISTRICT for the purposes set forth in this Agreement, and shall not be considered agents, employees, or SROs of DISTRICT.
- 8. <u>TERMINATION</u> Either party may terminate this Agreement at any time by giving written notice to the other party of such termination and specifying the effective date thereof, at least thirty (30) days before the effective date of such termination. In the event of termination, District shall pay for services actually rendered through the termination date only.

9. HOLD HARMLESS AND INDEMNIFICATION

A. DISTRICT shall indemnify and hold harmless the County, its Agencies, Districts, Special Districts and Departments, their respective directors, officers, Board of Supervisors, elected and appointed officials, employees, agents and representatives from any liability, claim, damage or action whatsoever, based or asserted upon any act or omission of

DISTRICT, its officers, employees, contractors, agents or representatives arising out of or in any way relating to this Agreement, including but not limited to property damage, bodily injury, or death. DISTRICT shall defend, at its sole cost and expense, including but not limited to attorney fees, cost of investigation, defense and settlements or awards, the County, its Agencies, Districts, Special Districts and Departments, their respective directors, officers, Board of Supervisors, elected and appointed officials, employees, agents and representatives in any such action or claim. With respect to any action or claim subject to indemnification herein by DISTRICT, DISTRICT shall, at its sole cost, have the right to use counsel of its own choice and shall have the right to adjust, settle, or compromise any such action or claim without the prior consent of County; provided, however, that any such adjustment, settlement or compromise in no manner whatsoever limits or circumscribes DISTRICT's indemnification of County. DISTRICT's obligations hereunder shall be satisfied when DISTRICT has provided to County the appropriate form of dismissal (or similar document) relieving the County from any liability for the action or claim involved. Any insurance coverage shall in no way limit or circumscribe DISTRICT's obligations to indemnify and hold harmless the County.

- County shall indemnify and hold harmless the DISTRICT, its Agencies, В. Districts, Special Districts and Departments, their respective directors, officers, elected and appointed officials, employees, agents and representatives from any liability, claim, damage or action whatsoever, based or asserted upon any act or omission of County, its officers, employees, contractors, agents or representatives arising out of or in any way relating to this Agreement, including but not limited to property damage, bodily injury, or death. County shall defend, at its sole cost and expense, including but not limited to attorney fees, cost of investigation, defense and settlements or awards, the DISTRICT, its Agencies, Districts, Special Districts and Departments, their respective directors, officers, elected and appointed officials, employees, agents and representatives in any such action or claim. With respect to any action or claim subject to indemnification herein by County, County shall, at its sole cost, have the right to use counsel of its own choice and shall have the right to adjust, settle, or compromise any such action or claim without the prior consent of DISTRICT; provided, however, that any such adjustment, settlement or compromise in no manner whatsoever limits or circumscribes County's indemnification of DISTRICT. County's obligations hereunder shall be satisfied when County has provided to DISTRICT the appropriate form of dismissal (or similar document) relieving the DISTRICT from any liability for the action or claim involved. Any insurance coverage shall in no way limit or circumscribe County's obligations to indemnify and hold harmless the DISTRICT.
- 10. <u>ASSIGNMENT</u> Neither this Agreement nor any duties or obligations under this Agreement may be assigned by DISTRICT without prior written consent of SHERIFF.
- 11. <u>ENTIRE AGREEMENT</u> This Agreement supersedes any and all agreements, either oral or written, between the parties, and contains all of the covenants and agreements between the parties with respect to the subject matter hereof. Each party acknowledges that no other agreement, understanding or promise, oral or otherwise, relative to this subject matter exists between the parties at the time of execution of this Agreement. Any modification of this Agreement shall be effective only if it is in writing and signed by both parties.

Failure on the part of SHERIFF to require exact, full, and complete compliance with any term of this Agreement shall not be construed in any manner as changing the terms hereof, or estopping SHERIFF from enforcement hereof.
- 14. <u>SEVERABILITY</u> If any provision of this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions will nevertheless continue in full force without being impaired or invalidated in any way.
